### Assumptions Used in Arriving at Fiscal Estimate

Under current law HEAB awards only 10 scholarships for schools that have enrollments of less than 80 students. The bill changes that law to award the ten scholarships to schools that have enrollments of less than 20 students. This bill increases the total potential scholarships by an additional 78 scholarships. This increase is the result of an assumption that schools with an enrollment of twenty to eighty is 78 schools. In order to fund the additional students an increase of the appropriation by \$87,750 in GPR dollars. This estimate does not cover the additional matching requirement for the schools.
