## 2017 ASSEMBLY BILL 445

July 19, 2017 - Introduced by Representatives SARGENT, ANDERSON, BERCEAU, BROSTOFF, CONSIDINE, CROWLEY, HEBL, KESSLER, KOLSTE, OHNSTAD, POPE, SHANKLAND, SINICKI, SUBECK, C. TAYLOR and ZAMARRIPA, cosponsored by Senators LARSON, CARPENTER, HANSEN, JOHNSON, MILLER and VINEHOUT. Referred to Committee on Insurance.

### *Analysis by the Legislative Reference Bureau*

This bill requires the establishment and operation of a Wisconsin Health Benefit Exchange, which is administered by the Badger Health Benefit Authority that is also created in the bill.

**ASSEMBLY BILL 445*****Badger Health Benefit Authority***

This bill creates the Badger Health Benefit Authority (authority) that is a public body corporate and politic that is created by state law but that is not a state agency. The authority is governed by a board of directors consisting of the commissioner of insurance, the secretary of employee trust funds, the director of the state Medical Assistance program, the executive directors of the Wisconsin Collaborative for Healthcare Quality and the Wisconsin Health Information Organization, and the following members who are nominated by the governor and, with the advice and consent of the senate, appointed for three-year terms: a member in good-standing of the American Academy of Actuaries, a health economist, an employee benefits specialist, a representative of small employers, a representative of an organization that represents consumer interests, a representative of organized labor, and an individual with experience in health care administration. The chairperson of the board is the commissioner. The board must appoint an executive director of the authority. The executive director must, among other duties, supervise the administrative affairs and general management and operation of the authority, employ professional and clerical staff, as necessary, and prepare the authority's annual budget.

The authority is not a state agency, so numerous laws that apply to state agencies do not apply to the authority. However, the authority is treated like a state agency in the following ways, among others: it is subject to auditing by the Legislative Audit Bureau; it is subject to open meeting and open records laws; and it is exempt from property tax, income tax, and sales and uses taxes. The authority has powers, including adopting bylaws and policies and procedures for the regulation of its affairs and conduct of its business; hiring employees; incurring debt; suing and being sued in its own name; and executing contracts. The bill establishes a process that the authority must use when it contracts for professional services. Under the bill, the authority is subject to civil liability for its acts or omissions except that the maximum amount recoverable in a civil action against the authority is \$100,000. However, a member of the authority's board of directors, the authority's executive director, or an authority employee is exempt from civil liability unless the member, director, or employee acted with willful misconduct or in intentional violation of the law. The bill also imposes restrictions on board members and the authority's executive director pertaining to conflicts of interest and requires board members and the executive director to file financial disclosures.

***Health benefit exchange***

Under the bill, the authority must establish and operate a Wisconsin Health Benefit Exchange in this state, must make qualified health plans, with effective dates on or before January 1, 2018, available to qualified individuals and qualified employers, and must seek federal grants and other funding for the purpose of the exchange. A qualified health plan is defined in the bill, generally, as a health benefit plan that covers the costs of health care services and that meets the certification criteria described in the federal Patient Protection and Affordable Care Act (PPACA). A qualified individual is defined in the bill, generally, as a citizen or national of the United States, or an alien lawfully present in the United States, who

is not imprisoned in a correctional facility and who resides in this state. A qualified employer is defined in the bill, generally, as a small employer with not more than 100 employees that either 1) has its principal place of business in this state and elects to provide coverage to all of its eligible employees, wherever employed, through the small business health options program component of the exchange (SHOP Exchange) established by the authority; or 2) elects to provide coverage through the SHOP Exchange to all of its eligible employees who are principally employed in this state.

Only health benefit plans that are certified by the authority as qualified health plans may be offered through the exchange. To be certified as a qualified health plan, a health benefit plan must provide the essential health benefits package described in PPACA, its premium rates and contract language must have been filed with and not disapproved by the commissioner, it must provide at least a bronze level of coverage, as determined by the authority in accordance with criteria developed by the secretary of the federal Department of Health and Human Services, its cost sharing must not exceed limits established in PPACA, the insurer offering it must meet specified criteria, and the authority must determine that making the plan available through the exchange is in the interest of qualified individuals and qualified employers in this state.

The authority must assign a rating to, and determine the level of coverage of, each qualified health plan offered through the exchange. The levels of coverage under PPACA are bronze, silver, gold, and platinum, and are based on what percentage of the full actuarial value of the benefits provided under the plan the benefits under the plan provides. An eligible employee of a qualified employer that provides coverage through the SHOP Exchange may enroll in any qualified health plan offered through the SHOP Exchange at the level of coverage specified by his or her employer.

After the exchange begins operating, no insurer may offer or issue health benefit plan coverage in this state to an individual or a small employer except through the exchange. Although any insurer that is authorized to do business in this state in one or more lines of insurance that includes health insurance may offer qualified health plans through the exchange, a health benefit plan may not be certified as a qualified health plan unless the insurer that offers it, among other things, is in good standing, charges the same premium for the plan regardless of whether it is offered directly by the insurer or through an insurance intermediary, offers through the exchange at least one qualified health plan in each of the silver and gold levels of coverage, and complies with regulations of the federal DHHS and any other requirements established by the authority. In addition, any insurer that seeks certification of a health benefit plan as a qualified health plan must provide a justification for any premium increase; must make specified information available to the public, such as data on enrollment and on the number of claims denied, claims payment policies and practices, and financial disclosures; and must permit individuals enrolled in the plan to learn the amount that an individual would be responsible for paying toward the cost of a specific item or service.

An insurer that offers coverage through the exchange must establish a toll-free hotline for providing information to enrollees and must pay a commission, determined by the authority, to an insurance intermediary who enrolls a qualified individual or employees of a qualified employer in a qualified health plan offered by the insurer through the exchange. For determining premiums, an insurer that offers coverage through the exchange may pool together all individuals and employees with coverage under all of the plans issued by the insurer through the exchange. To pay administrative expenses of the exchange, the authority may impose on each insurer offering plans through the exchange a surcharge that is based on the insurer's total premium or flat dollar amount per enrollee collected through the exchange.

The bill sets out numerous responsibilities for the authority with respect to the exchange. In addition to the administrative duties related to certifying and rating health benefit plans and enrolling qualified individuals and qualified employers, the authority must provide for the operation of a toll-free telephone hotline to respond to requests for assistance; establish an appeals process; establish and operate a service center to provide information; publicize the exchange; maintain an Internet site with comparative information about qualified health plans; screen applicants for eligibility for Medical Assistance and, if eligible, assist them to enroll in Medical Assistance; select, and award grants to, entities to serve as navigators for conducting public education activities and distributing information about, and facilitating enrollment in, qualified health plans; review the rate of premium growth within the exchange and outside of the exchange; and develop recommendations on whether qualified employers should be limited to small employers. The authority may establish risk adjustment mechanisms for the exchange, contract with a third-party administrator for services on behalf of the exchange, and establish sub-exchanges or other exchanges provided for under federal law. The authority must keep an accounting of all exchange-related activities and receipts and expenditures and annually submit a report of the accounting to the federal DHHS, the governor, the commissioner, and the legislature.

This proposal may contain a health insurance mandate requiring a social and financial impact report under s. 601.423, stats.

11 release, through the exchange and effective upon the date of his or her release, in  
12 Medical Assistance, a qualified health plan, or some other form of minimum  
13 essential coverage on the date of his or her release from incarceration.

14           (u) For those persons whose alcohol or other drug abuse or mental health  
15 treatment is not covered by a federally administered program, coordinate the  
16 relationships among the Medical Assistance program, the exchange, and the county  
17 departments under s. 51.42 or 51.437 to provide outpatient and inpatient mental  
18 health and alcohol or other drug abuse treatment with all of the following goals for  
19 the coordination:

20           1. Maximizing coverage and improving access through the exchange for  
21 outpatient and inpatient treatment of mental illness and alcohol or other drug abuse.

22           2. Improving the quality of treatment for persons with alcohol or other drug  
23 dependence or a mental illness.

24           3. Fully integrating the treatment for physical conditions, alcohol or other drug  
25 abuse, and mental illness.

1           4. Reducing the cost of the county departments under ss. 51.42 and 51.437 to  
2 taxpayers by avoiding unnecessary overlap between the improved coverage of  
3 alcohol or other drug abuse treatment or mental illness treatment by health plans  
4 offered through the exchange and the services provided by county departments  
5 under s. 51.42 or 51.437.

6           (v) Review the rate of premium growth within the exchange and outside the  
7 exchange, and consider the information in developing recommendations on whether  
8 to continue limiting qualified employer status to small employers.

9           (w) Credit the amount of any free choice voucher to the monthly premium of  
10 the plan in which a qualified employee is enrolled, in accordance with section 10108  
11 of the federal act, and collect the amount credited from the offering employer.

12           (x) Consult with stakeholders relevant to carrying out the activities required  
13 under this chapter, including any of the following:

14           1. Educated health care consumers who are enrollees in qualified health plans.

15           2. Individuals and entities with experience in facilitating enrollment in  
16 qualified health plans.

17           3. Representatives of small businesses and self-employed individuals.

18           4. The department of health services.

19           5. Advocates for enrolling hard-to-reach populations.

20           (y) Meet all of the following financial integrity requirements:

21           1. Keep an accurate accounting of all activities, receipts, and expenditures and  
22 annually submit to the secretary, the governor, the commissioner, and the legislature  
23 a report concerning such accountings.

24           2. Fully cooperate with any investigation conducted by the secretary under the  
25 secretary's authority under the federal act and allow the secretary, in coordination

1 with the inspector general of the federal department of health and human services,  
2 to do all of the following:

- 3 a. Investigate the affairs of the authority.
- 4 b. Examine the properties and records of the authority.
- 5 c. Require periodic reports in relation to the activities undertaken by the

7 3. In carrying out its activities under this chapter, not use any funds intended  
8 for the administrative and operational expenses of the authority for staff retreats,  
9 promotional giveaways, excessive executive compensation, or promotion of federal  
10 or state legislative or regulatory modifications, except that this subdivision does not  
11 prohibit the authority from advocating, as part of administering the exchange, for  
12 policies that the authority determines are in the best interest of the exchange or of  
13 individuals and employees receiving coverage through the exchange.

14 (2) The authority may do all of the following relating to the exchange under s.  
15 636.25 (1):

16 (a) Contract with a 3rd-party administrator for the provision of services on  
17 behalf of the exchange.

18 (b) Establish risk adjustment mechanisms for the exchange.

19 (c) Enter into agreements with or establish sub-exchanges.

20 (d) Create any other exchange, or component of the exchange, that is provided  
21 for under federal law.

22 (3) The authority shall seek grants to the fullest extent to which it is eligible,  
23 including amounts under section 1311 (a) (1) and (4) of the federal act, or other  
24 funding from the federal or state government for which it may be eligible and from  
25 private foundations for the purpose of the exchange under s. 636.25 (1).

1           **636.42 Health benefit plan certification.** (1) The authority may certify a  
2 health benefit plan as a qualified health plan if all of the following are true:

3           (a) The plan provides the essential health benefits package described in section

5 benefits that duplicate the minimum benefits of qualified dental plans, as provided  
6 in sub. (5), if all of the following are satisfied:

7           1. The authority has determined that at least one qualified dental plan is

14           (b) The premium rates and contract language have been filed with and not  
15 disapproved by the commissioner.

16           (c) The plan provides at least a bronze level of coverage, as determined under  
17 s. 636.30 (1) (e), unless the plan is certified as a qualified catastrophic plan, meets  
18 the requirements of the federal act for catastrophic plans, and will only be offered to  
19 individuals eligible for catastrophic coverage.

20           (d) The plan's cost-sharing requirements do not exceed the limits established  
21 under section 1302 (c) (1) of the federal act and, if the plan is offered through the  
22 SHOP Exchange, the plan's deductible does not exceed the limits established under  
23 section 1302 (c) (2) of the federal act.

24           (e) The health carrier offering the plan satisfies all of the following:

1           1. Is licensed and in good standing to offer health insurance coverage in this  
2 state.

3           2. Offers at least one qualified health plan in the silver level and at least one  
4 qualified health plan in the gold level through each component of the exchange in  
5 which the health carrier participates. In this subdivision, “component” refers to the  
6 SHOP Exchange or the exchange under s. 636.25 for individual coverage.

7           3. Charges the same premium rate for each qualified health plan without  
8 regard to whether the plan is offered directly from the health carrier or through an  
9 insurance intermediary.

10          4. Does not charge any cancellation fees or penalties in violation of s. 636.25  
11 (3).

12          5. Complies with the regulations developed by the secretary under section 1311  
13 (d) of the federal act and such other requirements as the authority may establish.

14          (f) The plan meets the requirements of certification as required by any rules  
15 promulgated under s. 636.46 (1) and by the secretary under section 1311 (c) of the  
16 federal act, including minimum standards in the areas of marketing practices,  
17 network adequacy, essential community providers in underserved areas,  
18 accreditation, quality improvement, uniform enrollment forms, and descriptions of  
19 coverage and information on quality measures for health benefit plan performance.

20          (g) The authority determines that making the plan available through the  
21 exchange under s. 636.25 (1) is in the interest of qualified individuals and qualified  
22 employers in this state.

23          **(2)** The authority shall not exclude a health benefit plan for any of the following  
24 reasons or in any of the following ways:

25           (a) On the basis that the plan is a fee-for-service plan.

2 (c) On the basis that the plan provides treatments necessary to prevent

6 health benefit plan as a qualified health plan to do all of the following:

7 (a) Submit a justification for any premium increase before implementation of  
8 that increase. The health carrier shall prominently post the information on its  
9 Internet site. The authority shall take this information, along with the information  
10 and the recommendations provided to the authority by the commissioner under 42  
11 USC 300gg-94 (b), into consideration when determining whether to allow the health  
12 carrier to make the plan available through the exchange under s. 636.25 (1).

13 (b) 1. Make available to the public, in the format described in subd. 2., and  
14 submit to the authority, the secretary, and the commissioner, accurate and timely  
15 disclosure of all of the following:

16 a. Claims payment policies and practices.

17 b. Periodic financial disclosures.

18 c. Data on enrollment.

19 d. Data on disenrollment.

20 e. Data on the number of claims that are denied.

21 f. Data on rating practices.

22 g. Information on cost sharing and payments with respect to any  
23 out-of-network coverage.

24 h. Information on enrollee and participant rights under title I of the federal act.

25 i. Other information as determined appropriate by the secretary.

1           2. The information required in subd. 1. shall be provided in plain language, as  
2 that term is defined in section 1311 (e) (3) (B) of the federal act.

3           (c) Permit individuals to learn, in a timely manner upon the request of the  
4 individual, the amount of cost sharing, including deductibles, copayments, and  
5 coinsurance, under the individual's plan or coverage that the individual would be  
6 responsible for paying with respect to the furnishing of a specific item or service by  
7 a participating provider. At a minimum, this information shall be made available  
8 to the individual through an Internet site and through other means for individuals  
9 without access to the Internet.

10           (4) The authority may not exempt any health carrier seeking certification of  
11 a health benefit plan as a qualified health plan, regardless of the type or size of the  
12 health carrier, from state licensure or solvency requirements and shall apply the  
13 criteria of this section in a manner that assures equitable treatment of all health  
14 carriers participating in the exchange under s. 636.25 (1).

15           (5) (a) The provisions of this chapter that are applicable to qualified health  
16 plans shall also apply to the extent relevant to qualified dental plans, except as  
17 modified in accordance with pars. (b), (c), and (d) or by regulations adopted by the  
18 authority.

19           (b) The health carrier shall be licensed to offer dental coverage, but need not  
20 be licensed to offer other health benefits.

21           (c) The plan shall be limited to dental and oral health benefits, without  
22 substantially duplicating the benefits typically offered by health benefit plans  
23 without dental coverage, and shall include, at a minimum, the essential pediatric  
24 dental benefits prescribed by the secretary under section 1302 (b) (1) (J) of the federal

1 act and such other dental benefits as the authority or the secretary may specify by  
2 regulation.

3 (d) Health carriers may jointly offer a comprehensive plan through the  
4 exchange under s. 636.25 (1) in which the dental benefits are provided by a health  
5 carrier through a qualified dental plan and the other benefits are provided by a  
6 health carrier through a qualified health plan, provided that the plans are priced  
7 separately and are also made available for purchase separately at the same price.

8 **636.43 Insurer requirements.** (1) Any health carrier that is authorized to  
9 do business in this state in one or more lines of insurance that includes health  
10 insurance may offer health benefit plans through the exchange under s. 636.25 (1).  
11 After the exchange becomes operational, no health carrier may offer or issue a health  
12 benefit plan in this state to an individual or to a small employer except through the  
13 exchange.

14 (2) For the purpose of determining premiums, a health carrier may pool  
15 together all individuals and employees who have coverage under all of the qualified  
16 health plans issued by the health carrier through the exchange under s. 636.25 (1).

17 (3) A health carrier that offers qualified health plans through the exchange  
18 under s. 636.25 (1) shall establish a toll-free hotline for providing information to  
19 enrollees and other individuals and shall furnish such reasonable reports as the  
20 authority determines necessary for the administration of the exchange.

21 (4) The authority may audit any health carrier that provides coverage under  
22 a qualified health plan through the exchange under s. 636.25 (1) for the purpose of  
23 ensuring that the health carrier is providing covered individuals with the benefits  
24 provided for under this subchapter in a manner that does all of the following:

25 (a) Complies with the provisions of this chapter.

1 (b) Promotes positive health outcomes.

2 (c) Advances value-based and evidence-based medical practices.

3 (d) Avoids unnecessary operating and capital costs arising from inappropriate  
4 utilization or inefficient delivery of health care services, unwarranted duplication of  
5 services and infrastructure, or creation of excess care delivery capacity.

6 (e) Holds down the growth of health care costs.

7 **636.44 Intermediaries.** An insurance intermediary that enrolls a qualified  
8 individual in a qualified health plan through the exchange under s. 636.25 (1) shall  
9 be paid a commission by the health carrier offering the qualified health plan. An  
10 insurance intermediary that enrolls the employees of a qualified employer in one or  
11 more qualified health plans through the exchange shall be paid a commission by each  
12 health carrier offering a qualified health plan selected by an employee of the  
13 qualified employer. The authority shall determine the commission amounts that  
14 must be paid to intermediaries under this section.

15 **636.45 Funding; publication of costs.** (1) For payment of administrative  
16 expenses, the authority may impose a surcharge on each health carrier offering  
17 qualified health plans through the exchange under s. 636.25 (1). The surcharge shall  
18 be based on the health carrier's total premium or flat dollar amount per enrollee  
19 collected through the exchange.

20 (2) The authority shall publish the average costs of licensing, regulatory fees,

8 Except as expressly provided to the contrary in this chapter, all health carriers

12 SUBCHAPTER III

13 BADGER HEALTH BENEFIT AUTHORITY

14 **636.70 Creation and organization of authority.** (1) There is created a  
15 public body corporate and politic to be known as the “Badger Health Benefit  
16 Authority.” The board of directors of the authority shall consist of the commissioner,  
17 or his or her designee; the secretary of employee trust funds, or his or her designee;  
18 the person who is appointed by the secretary of health services to be the director of  
19 the Medical Assistance program, or his or her designee; the executive director, or his  
20 or her designee, of the Wisconsin Collaborative for Healthcare Quality, if that  
21 organization exists; the executive director, or his or her designee, of the Wisconsin  
22 Health Information Organization, if that organization exists; and all of the following  
23 members, who shall be nominated by the governor and, with the advice and consent  
24 of the senate, appointed for 3-year terms except as provided in sub. (2):

25 (a) A member in good standing of the American Academy of Actuaries.

1 (b) A health economist.

2 (c) An employee benefits specialist.

3 (d) A representative of small employers.

4 (e) A representative of an organization that represents consumer interests.

5 (f) A representative of organized labor.

6 (g) An individual with experience in health care administration.

7 **(2)** No member of the board appointed under sub. (1) (a) to (g) may be a health  
8 care provider, as defined in s. 146.81 (1) (a) to (hp); an employee of a health care  
9 provider, as defined in s. 146.81 (1) (i) to (p); an employee of an insurer that is  
10 authorized to do business in the state; or an insurance intermediary.

11 **(3)** A vacancy on the board under sub. (1) shall be filled in the same manner  
12 as the original appointment to the board for the remainder of the unexpired term,  
13 if any.

14 **(4)** A member of the board under sub. (1) shall receive no compensation for  
15 services under this chapter but shall be reimbursed for actual and necessary  
16 expenses, including travel expenses, incurred in the discharge of the member's  
17 duties under this chapter.

18 **(5)** The commissioner or the commissioner's designee shall be the chairperson  
19 of the board under sub. (1). Seven members of the board constitute a quorum for the  
20 purpose of conducting the business and exercising the powers of the authority,  
21 notwithstanding the existence of any vacancy. The board may take action upon a vote  
22 of a majority of the members present, unless the bylaws of the authority require a  
23 larger number.

24 **(6)** The board under sub. (1) shall appoint an executive director who shall not  
25 be a member of the board and who shall serve at the pleasure of the board. The

1 executive director shall receive compensation commensurate with the duties of the  
2 office, as determined by the board. The executive director shall serve as secretary  
3 of the authority and shall keep a record of the proceedings of the authority and shall  
4 be custodian of all books, documents, and papers filed with the authority, the minute  
5 book or journal of the authority, and its official seal. The executive director or other  
6 person may cause copies to be made of all minutes and other records and documents  
7 of the authority and may give certificates under the official seal of the authority to  
8 the effect that such copies are true copies, and all persons dealing with the authority  
9 may rely upon such certificates. The executive director shall have all of the following  
10 duties:

11 (a) Supervising the administrative affairs and the general management and  
12 operation of the authority.

13 (b) Planning, directing, coordinating, and executing administrative functions  
14 in conformity with the policies and directives of the board.

15 (c) Employing professional and clerical staff, as necessary.

16 (d) Reporting to the board on all operations under his or her control and  
17 supervision.

18 (e) Preparing an annual budget and managing the administrative expenses of  
19 the authority.

20 (f) Undertaking any activities necessary to implement the powers and duties  
21 set forth in this chapter.

22 **636.72 Authority duties.** In addition to all other duties imposed under this  
23 chapter, the authority shall do all of the following:

24 (1) Establish its annual budget and monitor its fiscal management.

1           (2) No later than 2 years after an exchange under subch. II begins operation,  
2           and annually thereafter, submit a report to the legislature under s. 13.172 (2) and  
3           to the governor on the operation of any exchange under subch. II, including a review  
4           of all of the following:

5           (a) Progress toward the goals of the exchange.

6           (b) The operations and administration of the exchange.

7           (c) The types of health insurance plans available to eligible individuals and  
8           groups and the percentage of the total exchange enrollees served by each plan.

9           (d) Surveys and reports on the insurers' experiences with different plans,  
10          including aggregated data on enrollees, claims, statistics, complaint data, and  
11          enrollee satisfaction data.

12          (e) Significant observations regarding utilization and adoption of the  
13          exchange.

14          (3) Annually submit to the governor and the legislative audit bureau a  
15          statement of its activities and financial condition.

16          (4) Approve the use of any trademarks, seals, or logos by participating insurers  
17          and small employers.

18          (5) Comply with the requirements of s. 16.413 as if the authority is a state  
19          agency.

20          **636.74 Authority powers.** The authority has all of the powers necessary or  
21          convenient to carry out its duties under this chapter, except that it may not acquire  
22          or hold title to real estate or issue bonds. In addition, the authority may do any of  
23          the following:

24          (1) Adopt bylaws and policies and procedures for the regulation of its affairs  
25          and the conduct of its business.

1           (2) Have a seal and alter the seal at pleasure, have perpetual existence, and  
2 maintain an office.

3           (3) Hire employees, define their duties, and fix their rate of compensation.

4           (4) Delegate by resolution to one or more of its members any powers and duties  
5 that it considers proper.

6           (5) Incur debt.

7           (6) Appoint any technical or professional advisory committee that the  
8 authority finds necessary to assist the authority in exercising its duties and powers.  
9 If the authority appoints a committee, the authority shall define the duties of the  
10 committee and provide reimbursement for the expenses of the committee.

11           (7) Accept gifts, grants, loans, or other contributions from private or public  
12 sources.

13           (8) Procure liability insurance.

14           (9) Sue and be sued in its own name and plead and be impleaded.

15           (10) Execute contracts and other instruments, including contracts for  
16 professional or technical services required for the authority or the operation of an  
17 exchange under subch. II.

18           **636.76 Contracting for professional services.** (1) Whenever contracting  
19 for professional services, the authority shall solicit competitive sealed bids or  
20 competitive sealed proposals, whichever is appropriate. Each request for  
21 competitive sealed proposals shall state the relative importance of price and other  
22 evaluation factors.

23           (2) (a) When the estimated cost exceeds \$25,000, the authority may invite  
24 competitive sealed bids or proposals by publishing a class 2 notice under ch. 985 or  
25 by posting notice on the Internet at a site determined or approved by the authority.

1 The notice shall describe the contractual services to be purchased, the intent to make  
2 the procurement by solicitation of bids or proposals, any requirement for surety, and  
3 the date the bids or proposals will be opened, which shall be at least 7 days after the  
4 date of the last insertion of the notice or at least 7 days after the date of posting on  
5 the Internet.

6 (b) When the estimated cost is \$25,000 or less, the authority may award the  
7 contract in accordance with simplified procedures established by the authority for  
8 such transactions.

9 (c) For purposes of clarification, the authority may discuss the requirements  
10 of the proposed contract with any person who submits a bid or proposal and shall  
11 permit any offerer to revise his or her bid or proposal to ensure its responsiveness to  
12 those requirements.

13 **(3)** (a) The authority shall determine which bids or proposals are reasonably  
14 likely to be awarded the contract and shall provide each offerer of such a bid or  
15 proposal a fair and equal opportunity to discuss the bid or proposal. The authority  
16 may negotiate with each offerer in order to obtain terms that are advantageous to  
17 the authority. Prior to the award of the contract, any offerer may revise his or her  
18 bid or proposal. The authority shall keep a written record of all meetings,  
19 conferences, oral presentations, discussions, negotiations, and evaluations of bids or  
20 proposals under this section.

21 (b) In opening, discussing, and negotiating bids or proposals, the authority may  
22 not disclose any information that would reveal the terms of a competing bid or  
23 proposal.

24 **(4)** (a) After receiving each offerer's best and final offer, the authority shall  
25 determine which proposal is most advantageous and shall award the contract to the

1 person who offered it. The authority's determination shall be based only on price and  
2 the other evaluation factors specified in the request for bids or proposals. The  
3 authority shall state in writing the reason for the award and shall place the  
4 statement in the contract file.

5 (b) Following the award of the contract, the authority shall prepare a register  
6 of all bids or proposals.

7 **636.78 Political activities. (1)** No employee of the authority may directly  
8 or indirectly solicit or receive subscriptions or contributions for any partisan political  
9 party or any political purpose while engaged in his or her official duties as an  
10 employee. No employee of the authority may engage in any form of political activity  
11 calculated to favor or improve the chances of any political party or any person seeking  
12 or attempting to hold partisan political office while engaged in his or her official  
13 duties as an employee or engage in any political activity while not engaged in his or  
14 her official duties as an employee to such an extent that the person's efficiency during  
15 working hours will be impaired or that he or she will be tardy or absent from work.  
16 Any violation of this section is adequate grounds for dismissal.

17 (2) If an employee of the authority declares an intention to run for partisan  
18 political office, the employee shall be placed on a leave of absence for the duration  
19 of the election campaign and if elected shall no longer be employed by the authority  
20 on assuming the duties and responsibilities of such office.

21 (3) An employee of the authority may be granted, by the executive director, a  
22 leave of absence to participate in partisan political campaigning.

23 (4) Persons on leave of absence under sub. (2) or (3) shall not be subject to the  
24 restrictions of sub. (1), except as they apply to the solicitation of assistance,  
25 subscription, or support from any other employee in the authority.

1           **636.80 Financial disclosure. (1)** In this section, “individual required to file”  
2 means a person who is a member of the board of the authority or the executive  
3 director of the authority.

4           **(2)** Each individual who in January of any year is an individual required to file  
5 shall file with the ethics commission no later than April 30 of that year a statement  
6 of economic interests meeting each of the requirements of s. 19.44 (1). The  
7 information contained on the statement shall be current as of December 31 of the  
8 preceding year.

9           **(3)** An individual required to file shall file with the ethics commission a  
10 statement of economic interests meeting each of the requirements of s. 19.44 (1) no  
11 later than 21 days following the date he or she assumes a position on the board or  
12 the position of executive director if the individual required to file has not previously  
13 filed a statement of economic interests with the ethics commission during that year.  
14 The information on the statement shall be current as per the date he or she assumes  
15 the position.

16           **(4)** If an individual required to file fails to make a timely filing, the ethics  
17 commission shall promptly provide notice of the delinquency to the secretary of  
18 administration, and to the executive director of the authority, or the chairperson of  
19 the board if the executive director’s filing is untimely. Upon such notification, both  
20 the secretary of administration and the executive director, or chairperson, shall  
21 withhold all payments for compensation, reimbursement of expenses, and other  
22 obligations to the individual until the ethics commission notifies those to whom  
23 notice of the delinquency was provided that the individual has complied with this  
24 section.

1           (5) On its own motion or at the request of any individual required to file a  
2 statement of economic interests, the ethics commission may extend the time for filing  
3 or waive any filing requirement if the ethics commission determines that the literal  
4 application of the filing requirements of this subchapter would work an  
5 unreasonable hardship on that individual or that the extension of the time for filing  
6 or waiver is in the public interest. The ethics commission shall set forth in writing  
7 as a matter of public record its reason for the extension or waiver.

8           (6) (a) Any person who violates this section may be required to forfeit not more  
9 than \$500 for each violation. If the court determines that the accused has realized  
10 economic gain as a result of the violation, the court may, in addition, order the  
11 accused to forfeit the amount gained as a result of the violation. The attorney  
12 general, when so requested by the ethics commission, shall institute proceedings to  
13 recover any forfeiture incurred under this subsection that is not paid by the person  
14 against whom it is assessed.

15           (b) Any person who intentionally violates this section shall be fined not less  
16 than \$100 nor more than \$5,000 or imprisoned not more than one year in the county  
17 jail or both.

18           **636.82 Conflict of interest prohibited; exception.** (1) Except in  
19 accordance with the ethics commission's advice under s. 19.46 (2) and except as  
20 otherwise provided in sub. (2), a member of the board under s. 636.70 (1) and the  
21 executive director of the authority may not do any of the following:

22           (a) Take any official action substantially affecting a matter in which the board  
23 member or executive director, a member of his or her immediate family, or an  
24 organization with which the board member or director is associated has a substantial  
25 financial interest.

1 (b) Use his or her office or position in a way that produces or assists in the  
2 production of a substantial benefit, direct or indirect, for the board member or

20 **636.84 Liability; expenses; limitations.** (1) Neither the state, nor any

23 liable for any debt, obligation, act, or omission of the authority.

24 (2) All of the expenses incurred by the authority in exercising its duties and  
25 powers under this chapter shall be payable only from funds of the authority.
