AMENDING A RULE

To amend Ins 3.46 (1) and (3) (b) relating to standards for nursing home insurance.

ANALYSIS BY THE COMMISSIONER OF INSURANCE

It is proposed that the reference to s. 632.78 (4), Stats., in s. Ins 3.46 (1) and (3) (b) be replaced by s. 632.895 (3), Stats., to accurately reflect the current renumbering of the statutory section which mandates the minimum coverage for skilled nursing care in every disability insurance policy. Due to renumbering of s. 632.78 (4), Stats., by Ch. 39, Laws of 1981, the statutory reference in Ins 3.46 (1) and (3) (b), relating to standards for nursing home insurance, is no longer current. This rule interprets ss. 631.20 (2) and 628.34 (11) and (12).

0002R1 02/18/85 Pursuant to the authority vested in the Commissioner of Insurance by s. 601.41 (3), Stats., the Commissioner hereby amends a rule interpreting ss. 631.20 (2) and 628.34 (11) and (12), Stats., as follows:

SECTION 1. Ins 3.46 (1), Wisconsin Administrative Code, is amended to read:

Ins 3.46 Standards for nursing home insurance. (1) Findings. Information on file in the office of the commissioner of insurance shows that significant misunderstanding exists with respect to nursing home In many cases, coverage under these policies is much less insurance. than the use of the label would warrant and includes few meaningful benefits beyond those already available to consumers as a result of s. 632-78-(4) 632.895 (3), Stats., and Ins 3.39, and the commissioner of insurance finds that such policies are inequitable, misleading, deceptive, obscure, and encouraging of misrepresentation as considered by s. 631.20 (2), Stats. Some of the sales presentations used to sell nursing home insurance are misleading, confusing, and incomplete, and the commissioner of insurance finds that such presentations are misleading and deceptive, and restrain competition unreasonably under s. 628.34 (12), Stats., and their continued use would constitute an unfair trade practice under s. 628.34 (11), Stats.

SECTION 2. Ins 3.46 (3) (b), Wisconsin Administrative Code, is amended to read:

Ins 3.46 (3) (b). This section shall not apply to a rider designed specifically to meet the requirement for coverage of skilled nursing care set forth in s. $632 \cdot 78 - (4)$ <u>632.895 (3)</u>, Stats.

As provided in s. 227.026 (1) (intro.), Stats., this rule shall take effect on the first day of the month following its publication.
