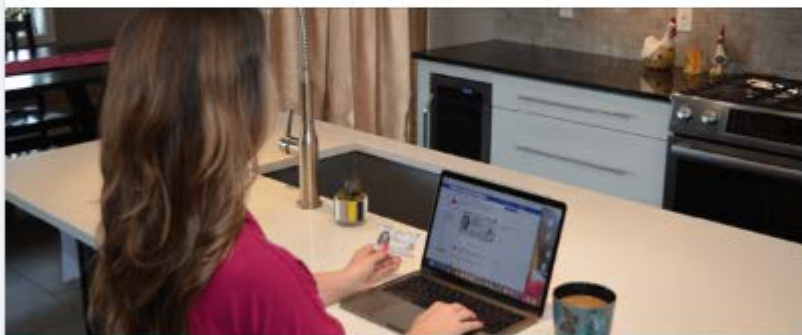


ONLINE LICENSE RENEWAL: Starting May 11, many people will be able to renew their driver licenses online! About 80,000 people have had their driver licenses expire during the COVID-19 pandemic. Each week that passes, another 10,000 licenses expire. Wisconsin DMV's dedication to serving customers while keeping public health and safety a priority, led to an innovative move to shift driver license renewal from an in-person task, to an online task

The renewed license will be valid for eight years. After that eight-year period, customers will have to return to a DMV service center for a new photo. At \$34, the renewal fee remains the same. While the federal REAL ID deadline has been extended to October 1, 2021, people wanting a driver license that is REAL ID compliant will have to visit a DMV service center in-person. Driver licenses that expire during the Safer at Home order are extended 60 days past the end of the order. The extension and waived late fees expire on July 25, 2020.
