INITIAL REGULATORY FLEXIBILITY ANALYSIS. This rulemaking impacts, among others, developers and installers of distributed generation facilities; utility customers who use or may seek to use distributed generation technologies; and stakeholders interested in the development and deployment of distributed generation technologies. Any one of these maybe a “small business” as defined by Wis. Stat. § 227.114 (12). The revisions proposed in this rule are intended to support clearer and more cost-efficient implementation and compliance, including through updated technical requirements, greater transparency of information provided from utilities to applicants, and more flexibility to achieve compliance with general financial requirements. Implementing these new requirements may in some cases also require additional effort and compliance costs from involved parties, such as additional time to review, understand, and ensure compliance with updated technical standards. However, additional compliance costs and effort are expected to be limited and counterbalanced by the updates that will provide greater efficiencies, resulting in approximately zero net overall impact on involved parties.

WISCONSIN ENVIRONMENTAL POLICY ACT. This is a Type III action under Wis. Admin. Code § PSC 4.10 (3). The Commission has reviewed the potential environmental effects of the project. The proposed revisions will not result in possible significant adverse environmental or social impacts. The preparation of an environmental impact statement under Wis. Stat. §1.11 or an environmental assessment is not necessary
