Notice regarding the effective date of certain provisions in 2023 Wisconsin Act 12

2023 Wisconsin Act 12, section 244 (4), requires the City of Milwaukee Employes' Retirement System and the Milwaukee County Retirement Plan to notify the Legislative Reference Bureau of the date on which an ordinance imposing a sales and use tax is adopted under s. 77.70 (2) (a) or 77.701 (1), Wis. Stats.

2023 Wisconsin Act 12, section 246 (1), provides that certain changes in the act¹ take effect on the January 1 of the year following the year that the aforementioned ordinance is adopted.

The notices received by the Legislative Reference Bureau are published below.

Therefore, pursuant to 2023 Wisconsin Act 12, section 246 (1), the referenced changes made by 2023 Wisconsin Act 12 will become effective January 1, 2024.
