2	<b>1.</b> Page 3, line 4: after "placed on a" insert " <u>desk or other</u> ".
3	${f 2.}$ Page 3, line 8: delete " <u>or printer with optional floor stand</u> " and substitute
4	" <u>; an automated teller machine, as defined in s. 134.85 (1) (a)</u> ".
5	<b>3.</b> Page 6, line 2: after that line insert:
6	<b>"SECTION 16m.</b> 287.17 (4) (d) 1. of the statutes is amended to read:
7	287.17 (4) (d) 1. Determine the manufacturer's target recycling weight by
8	multiplying the number of pounds of the manufacturer's covered electronic devices
9	sold to households or schools in this state during the program year that began $\frac{36}{36}$
10	months <u>3 program years</u> before the beginning of the program year in which the
11	calculation is made, as reported under sub. (5) (a), by 0.8.".
12	<b>4.</b> Page 6, line 4: on lines 4 and 9, delete "The" and substitute " <del>The</del> <u>Subject to</u>
13	<u>subd. 1. d., the</u> ".

16	department the total weight of eligible electronic devices collected in this state that
17	the recycler received for recycling on behalf of a manufacturer registered under sub.
18	(3) during the preceding program year and the name of the manufacturer.".
