**ASSEMBLY AMENDMENT 1,
TO SENATE AMENDMENT 1,
TO ASSEMBLY BILL 245**

June 14, 2023 - Offered by Representatives NEUBAUER, SNODGRASS, CLANCY, VINING, BARE, MOORE OMOKUNDE, MADISON, JACOBSON, CONSIDINE, RATCLIFF, C. ANDERSON, ANDRACA, JOERS, HAYWOOD, SINICKI, BILLINGS, J. ANDERSON, ORTIZ-VELEZ, BALDEH, OHNSTAD, SHELTON, DRAKE, PALMERI, CONLEY, CABRERA, HONG, EMERSON and STUBBS.

1 At the locations indicated, amend the amendment as follows:

21 under s. 20.005 (3) for the appropriation to the department of revenue under s. 20.566
22 (2) (a), the dollar amount for fiscal year 2023-24 is increased by \$150,000 and the
23 dollar amount for fiscal year 2024-25 is increased by \$150,000 to increase the
24 authorized FTE positions for the department by 2.0 GPR project positions for the

1 period ending July 1, 2025, to implement the repeal under this act of personal
2 property taxes under ch. 70.”.
