**ASSEMBLY AMENDMENT 2,  
TO ASSEMBLY BILL 304**

June 21, 2023 - Offered by Representative Vos.

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 24, line 2: after that line insert:

3 “**SECTION 3g.** 40.02 (48) (am) 19. of the statutes is amended to read:

4 40.02 **(48)** (am) 19. ~~An excise tax investigator~~ A special agent employed by the  
5 department of revenue who is authorized to act under s. 73.031.

6 **SECTION 3r.** 40.02 (48) (c) of the statutes is amended to read:

7 40.02 **(48)** (c) In s. 40.65, “protective occupation participant” means a  
8 participating employee who is a police officer, fire fighter, an individual determined  
9 by a participating employer under par. (a) or (bm) to be a protective occupation  
10 participant, county undersheriff, deputy sheriff, state probation and parole officer,  
11 county traffic police officer, conservation warden, state forest ranger, field  
12 conservation employee of the department of natural resources who is subject to call  
13 for forest fire control or warden duty, member of the state traffic patrol, state motor

1 vehicle inspector, University of Wisconsin System full-time police officer, guard or  
2 any other employee whose principal duties are supervision and discipline of inmates  
3 at a state penal institution, ~~excise tax investigator~~ special agent employed by the  
4 department of revenue who is authorized to act under s. 73.031, person employed  
5 under s. 60.553 (1), 61.66 (1), or 62.13 (2e) (a), or special criminal investigation agent  
6 employed by the department of justice.”.

7 **2.** Page 26, line 19: after “a” insert “substantial”.

8 **3.** Page 151, line 4: after that line insert:

9 “**SECTION 298g.** 230.36 (1m) (b) 2. (intro.) of the statutes is amended to read:

10 230.36 (**1m**) (b) 2. (intro.) A conservation warden, conservation patrol boat  
11 captain, conservation patrol boat engineer, member of the state patrol, state motor  
12 vehicle inspector, University of Wisconsin System police officer, security officer, or  
13 security person, other state facilities police officer, special tax agent, ~~excise tax~~  
14 ~~investigator~~ special agent employed by the department of revenue who is authorized  
15 to act under s. 73.031, and special criminal investigation agent employed by the  
16 department of justice at all times while:

17 **SECTION 298r.** 230.36 (2m) (a) 9. of the statutes is amended to read:

18 230.36 (**2m**) (a) 9. A ~~excise tax investigator~~ special agent employed by the  
19 department of revenue who is authorized to act under s. 73.031.”.
