



**ASSEMBLY AMENDMENT 1,
TO ASSEMBLY SUBSTITUTE AMENDMENT 1,
TO ASSEMBLY BILL 966**

February 14, 2024 - Offered by Representative TUSLER.

1 At the locations indicated, amend the substitute amendment as follows:

2 **1.** Page 5, line 18: delete "(a)".

3 **2.** Page 5, line 22: delete "paragraph" and substitute "subsection".

4 **3.** Page 6, line 1: delete "paragraph" and substitute "subsection".

5 **4.** Page 6, line 3: delete lines 3 to 5.

6 **5.** Page 8, line 21: delete lines 21 to 24 and substitute:

7 "(e) "Judicial officer" means a person who currently is or who formerly was any

8 of the following:

9 1. A supreme court justice.

10 2. A court of appeals judge.

11 3. A circuit court judge.

1 4. A municipal judge.

2 5. A tribal judge.

3 6. A temporary or permanent reserve judge.

4 7. A circuit, supplemental, or municipal court commissioner.”.

5 **6.** Page 11, line 10: after “family” insert “, provided that the judicial officer has
6 made a written request to the data broker. The data broker shall cease knowingly
7 selling, licensing, trading, purchasing, or otherwise making available personal
8 information for consideration pursuant to the written request within 10 business
9 days of the written request”.

10 **7.** Page 11, line 25: delete the material beginning with “remove” and ending
11 with “removed.” on page 12, line 4, and substitute “remove, within 10 business days,
12 the publicly posted or displayed personal information identified in the request;
13 ensure that the information is not publicly posted or displayed on any website or
14 subsidiary website controlled by that person, business, or association; and identify
15 any other publicly posted or displayed instances of the identified information that
16 should also be removed.”.

17 **8.** Page 12, line 16: after “person,” insert “data broker,”.

18 **9.** Page 12, line 22: after “person,” insert “data broker,”.

19 **10.** Page 14, line 4: after “person,” insert “data broker,”.

20 **11.** Page 14, line 10: after “person,” insert “data broker,”.

21 **12.** Page 14, line 17: after that line insert:

22 “4. A judicial officer under sub. (1) (e) 1. to 3., or 6. may designate the director
23 of state courts as the judicial officer’s agent for purposes of service of process, and if
24 the director of state courts receives service of process, notice, or demand required or

1 permitted by law to be served on a judicial officer who has designated the director
2 of state courts as his or her agent for purposes of service of process under this
3 subdivision, the director of state courts shall forward the process, notice, or demand
4 to the judicial officer's home address.

5 **(4m)** (a) In this subsection, "land records website" means a public website that
6 allows users to search and retrieve a real estate property database or geographic
7 records.

8 (b) Any provider of a public-facing land records website shall establish a
9 process for judicial officers and immediate family members of judicial officers to opt
10 out from the display and search functions of their names on the provider's
11 public-facing land records website.".
