**SENATE SUBSTITUTE AMENDMENT 1,  
TO SENATE BILL 329**

June 23, 2023 - Offered by Senator STROEBEL.

1     **AN ACT** *to repeal* 15.374 (2) and 115.39; *to renumber and amend* 118.19 (12);  
2           *to amend* 15.01 (6), 115.28 (7) (a), 115.38 (1) (a), 118.015 (title), 118.015 (2),  
3           118.015 (3) (a), 118.33 (6) (b) 3. and 121.02 (1) (c) 3.; *to repeal and recreate*  
4           118.016; and *to create* 15.374 (2), 15.377 (9), 115.385 (1) (e), 115.39, 118.015  
5           (1c), 118.015 (1m), 118.015 (5), 118.19 (12) (a) and (b), 118.33 (5m), 118.33 (6)  
6           (a) 3., 118.33 (6) (b) 2m., 118.33 (6) (c) 3., 118.33 (6) (cr) 3. and 119.44 (2) (bm)  
7           of the statutes; **relating to:** reading instruction in public schools and private  
8           schools participating in parental choice programs, an early literacy assessment  
9           and intervention program, providing an exemption from rule-making  
10          procedures, and granting rule-making authority.

***Analysis by the Legislative Reference Bureau***

This substitute amendment differs from 2023 Assembly Bill 321 in the following respects:

1. Under the substitute amendment, by January 1, 2025, the Department of Public Instruction must establish a model policy for promoting third grade pupils to

the fourth grade that includes a requirement that a pupil who scores in the lowest proficiency category on the third grade reading assessment and is promoted to fourth grade be retained in third grade reading. Under the bill, DPI's model policy for promoting third grade pupils to the fourth grade must include a requirement that a pupil who scores in the lowest proficiency category on the third grade reading assessment be retained in the third grade.

Under the bill, by July 1, 2025, school boards, independent charter schools, and private schools participating in a parental choice program must adopt written policies for promoting a third grade pupil to the fourth grade that include all of the components that are required to be in DPI's model policy. Under the bill, beginning on September 1, 2028, school boards, independent charter schools, and private schools participating in a parental choice program are prohibited from promoting a third grade pupil unless the pupil complies with their respective promotion policy. Under the substitute amendment this prohibition begins on September 1, 2027.

2. The substitute amendment removes the provision in the bill that requires a school board, charter school, or private school participating in a parental choice program that chooses to adopt a new early literacy curriculum on or after January 1, 2024, to adopt an early literacy curriculum recommended by DPI. Additionally, beginning in the 2024-25 school year, the bill prohibits public schools, including charter schools, from providing instruction to pupils in grades kindergarten to three that incorporates three-cueing in the core reading curriculum or in supplemental materials, including materials used for reading intervention. The substitute amendment extends this prohibition to private schools participating in a parental choice program.

3. With regard to the professional development training required under the bill, the substitute amendment replaces Voyager Sopris with Lexia Learning Systems, LLC, the current legal name for the entity that publishes Language Essentials for Teachers of Reading and Spelling (LETRS).

***The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:***

1           **SECTION 1.** 15.01 (6) of the statutes is amended to read:  
2           15.01 (6) "Division," "bureau," "section," and "unit" means the subunits of a  
3           department or an independent agency, whether specifically created by law or created  
4           by the head of the department or the independent agency for the more economic and  
5           efficient administration and operation of the programs assigned to the department  
6           or independent agency. The office of credit unions in the department of financial  
7           institutions, the office of the inspector general in the department of children and

1 families, the office of the inspector general in the department of health services, and  
2 the office of children’s mental health in the department of health services have the  
3 meaning of “division” under this subsection. The office of the long-term care  
4 ombudsman under the board on aging and long-term care and the office of  
5 educational accountability and the office of literacy in the department of public  
6 instruction have the meaning of “bureau” under this subsection.

7 **SECTION 2.** 15.374 (2) of the statutes is created to read:

8 15.374 (2) OFFICE OF LITERACY. There is created an office of literacy, to be known  
9 as the Wisconsin Reading Center, in the department of public instruction. The  
10 director of the office shall be nominated by the state superintendent of public  
11 instruction after consultation with the council on early literacy curricula, and with  
12 the advice and consent of the senate appointed, to serve at the pleasure of the state  
13 superintendent of public instruction.

14 **SECTION 3.** 15.374 (2) of the statutes, as created by 2023 Wisconsin Act .... (this  
15 act), is repealed.

16 **SECTION 4.** 15.377 (9) of the statutes is created to read:

17 15.377 (9) COUNCIL ON EARLY LITERACY CURRICULA. (a) There is created in the  
18 department of public instruction a council on early literacy curricula composed of 9  
19 members who have knowledge of or experience with science-based early literacy  
20 instruction, as defined in s. 118.015 (1c) (b), and literacy curricula for pupils in grades  
21 kindergarten to 3. The members of the council shall be appointed for staggered  
22 3-year terms, as follows:

23 1. Three members appointed by the speaker of the assembly.

24 2. Three members appointed by the senate majority leader.

25 3. Three members appointed by the state superintendent of public instruction.

1 (b) An individual may not serve as a member of the council under this  
2 subsection if any of the following applies:

3 1. The individual has a financial interest in an entity that develops, sells, or  
4 markets a product to assess reading ability.

5 2. The individual has a financial interest in an entity that develops, sells, or  
6 markets a product specifically intended to be used to teach reading.

7 3. The individual has a financial interest in an entity that develops, sells, or  
8 markets a product to treat reading difficulties.

9 (c) For purposes of par. (b), “financial interest in an entity” includes all of the  
10 following:

11 1. A direct or indirect ownership interest in the entity.

12 2. Receiving income from the entity during the 12 months preceding the  
13 consideration for appointment under par. (a).

14 **SECTION 5.** 115.28 (7) (a) of the statutes is amended to read:

15 115.28 (7) (a) License all teachers for the public schools of the state; make rules  
16 establishing standards of attainment and procedures for the examination and  
17 licensing of teachers within the limits prescribed in ss. 118.19 (2) and (3), 118.191,  
18 118.1915, 118.192, 118.193, 118.194, 118.195, and 118.197; prescribe by rule  
19 standards, requirements, and procedures for the approval of teacher preparatory  
20 programs leading to licensure, including a requirement that, to be approved by the  
21 state superintendent, a teacher preparatory program shall demonstrate that it  
22 provides instruction that prepares teachers to teach reading and language arts using  
23 science-based early reading instruction, as defined in s. 118.015 (1c) (b), and does not  
24 provide instruction on teaching reading and language arts that incorporates  
25 3-cueing, as defined in s. 118.015 (1c) (c), and a requirement that, beginning on July

1 1, 2012, and annually thereafter, each teacher preparatory program located in this  
2 state shall submit to the department a list of individuals who have completed the  
3 program and who have been recommended by the program for licensure under this  
4 subsection, together with each individual's date of program completion, from each  
5 term or semester of the program's most recently completed academic year; file in the  
6 state superintendent's office all papers relating to state teachers' licenses; and  
7 register each such license.

8 **SECTION 6.** 115.38 (1) (a) of the statutes is amended to read:

9 115.38 (1) (a) Indicators of academic achievement, including the performance  
10 of pupils on the tests administered under s. 121.02 (1) (r), the performance of pupils  
11 on assessments required under s. 118.016 (3), and the performance of pupils, by  
12 subject area, on the statewide assessment examinations administered under s.  
13 118.30.

14 **SECTION 7.** 115.385 (1) (e) of the statutes is created to read:

15 115.385 (1) (e) For a school district other than a union high school district and  
16 for each school that offers grade 3 in that school district, the number and percentage  
17 of pupils who scored in the lowest proficiency category on the standardized reading  
18 test administered under s. 121.02 (1) (r).

19 **SECTION 8.** 115.39 of the statutes is created to read:

20 **115.39 Literacy coaching program. (1) DEFINITIONS.** In this section:

21 (a) "CESA region" means the geographic territory within the boundaries of a  
22 cooperative educational service agency.

23 (b) "Eligible school" means any of the following that does not provide  
24 instruction that incorporates 3-cueing, as defined in s. 118.015 (1c) (c), in the core  
25 reading curriculum for grades kindergarten to 3:

1           1. A public school, including a charter school established under s. 118.40 (2r)  
2 or (2x).

3           2. A private school participating in a program under s. 118.60 or 119.23.

4           (c) "Office" means the office of literacy in the department.

5           **(2) LITERACY COACHING PROGRAM.** The office shall establish and supervise an  
6 early literacy coaching program to improve literacy outcomes in this state. As part  
7 of the early literacy coaching program established under this subsection, the office  
8 shall, in consultation with cooperative educational service agencies, do all of the  
9 following:

10           (a) Contract with individuals who demonstrate knowledge and expertise in  
11 science-based early literacy instruction and instructional practices, and have  
12 instructional experience in grades kindergarten to 12 to serve as literacy coaches.  
13 The office may not contract for more than 64 full-time equivalent positions under  
14 this paragraph.

15           (b) Provide ongoing training on science-based early literacy instruction and  
16 instructional practices and supervision to individuals with whom the office contracts  
17 under par. (a).

18           (c) Prohibit literacy coaches from using or promoting instruction that includes  
19 3-cueing, as defined in s. 118.015 (1c) (c).

20           **(3) PARTICIPATION; SCHOOLS AND SCHOOL DISTRICTS.** (a) The office shall assign  
21 one-half of the number of literacy coaches under sub. (2) (a) as follows:

22           1. Based on scores of the standardized reading test administered to pupils  
23 during the prior school year under s. 121.02 (1) (r), the office shall identify the 50  
24 eligible schools that had the lowest percentage of pupils score as proficient in reading

1 at grade level and the 50 eligible schools that had the largest gap in pupils who scored  
2 as proficient in reading at grade level.

3 2. a. Subject to par. (c) and subd. 2. b., from the eligible schools identified under  
4 subd. 1., the office shall select the eligible schools that the office determines have the  
5 greatest need for early literacy instructional coaching and shall assign at least one  
6 but no more than 3 eligible schools selected under this subdivision to each full-time  
7 equivalent literacy coach.

8 b. From the eligible schools identified under subd. 1., the office shall select at  
9 least two eligible schools that are private schools participating in a program under  
10 s. 118.60 or 119.23.

11 (b) The office shall assign one-half of the number of literacy coaches under sub.  
12 (2) (a), in consultation with cooperative educational service agencies, to eligible  
13 schools that request early literacy support. The office shall assign literacy coaches  
14 under this paragraph in a manner that allocates the literacy coaches evenly across  
15 CESA regions.

16 (c) 1. The total number of full-time equivalent literacy coaches assigned under  
17 pars. (a) and (b) to eligible schools located within the geographical boundaries of a  
18 school district may not exceed the following:

19 a. For a first class city school district, 10.

20 b. For a school district other than a first class city school district, 4.

21 2. The total number of full-time equivalent literacy coaches assigned under  
22 pars. (a) and (b) to eligible schools located within a CESA region may not be fewer  
23 than 3.

24 (d) The office shall ensure that a school assigned a literacy coach under par. (a)  
25 or (b) does not request or require that the literacy coach perform duties outside the

1 individual's role as a literacy coach. For purposes of this paragraph, the role of a  
2 literacy coach is to provide support to administrators, school-based literacy coaches,  
3 principals, and teachers to build teacher and school capacity to teach reading and  
4 language arts using science-based early reading instruction, as defined in s. 118.015  
5 (1c) (b), in order to increase the percentage of pupils who are reading at grade level  
6 by the end of grade 3.

7 **(4) REPORT.** By October 15, 2024, and by each October 15 thereafter, the office  
8 shall submit a report to the joint committee on finance that includes at least all of  
9 the following for the previous school year:

10 (a) The number of literacy coaches assigned to schools under sub. (3) (a) and  
11 (b).

12 (b) The number of schools that were assigned a literacy coach under sub. (3) (a)  
13 and the number of schools that were assigned a literacy coach under sub. (3) (b).

14 (c) The number of contracts that the office entered into under sub. (2) (a) and  
15 the number of contracts under sub. (2) (a) that were terminated.

16 (d) The number of requests submitted for a literacy coach under sub. (3) (b).

17 (e) The results of the standardized reading test administered under s. 121.02  
18 (1) (r) and assessments under s. 118.016 in schools that were assigned a literacy  
19 coach under sub. (3) (a) or (b).

20 (f) A description of the training provided under sub. (2) (b).

21 (g) For the 2023-24 and 2024-25 school years, the number of individuals who  
22 completed the mandatory professional development training under 2023 Wisconsin  
23 Act .... (this act), section 27 (2).

24 **SECTION 9.** 115.39 of the statutes, as created by 2023 Wisconsin Act .... (this  
25 act), is repealed.



1           **SECTION 10.** 118.015 (title) of the statutes is amended to read:

2           **118.015** (title) **Reading instruction; early literacy curricula and**  
3 **instructional materials.**

4           **SECTION 11.** 118.015 (1c) of the statutes is created to read:

5           118.015 (1c) DEFINITIONS. In this section:

6           (a) “Phonics” means the study of the relationships between sounds and words;  
7 this includes alphabetic principle, decoding, orthographic knowledge, encoding, and  
8 fluency.

9           (b) “Science-based early reading instruction” means instruction that is  
10 systematic and explicit and consists of at least all of the following:

11           1. Phonological awareness, including word awareness, rhyme recognition,  
12 repetition and creation of alliteration, syllable counting or identification, onset, and  
13 rime manipulation.

14           2. Phonemic awareness, including phoneme identification, isolation, blending,  
15 segmentation, addition, substitution, and deletion.

16           3. Phonics.

17           4. Building background knowledge.

18           5. Oral language development.

19           6. Vocabulary building to develop lexical and morphological knowledge.

20           7. Instruction in writing.

21           8. Instruction in comprehension.

22           9. Reading fluency.

23           (c) “Three-cueing” means any model, including the model referred to as  
24 meaning, structure, and visual cues, or MSV, of teaching a pupil to read based on  
25 meaning, structure and syntax, and visual cues or memory.

1           **SECTION 12.** 118.015 (1m) of the statutes is created to read:

2           118.015 **(1m)** EARLY LITERACY CURRICULA AND INSTRUCTIONAL MATERIALS. (a)  
3           Beginning in the 2023-24 school year and annually thereafter, the council on early  
4           literacy curricula shall recommend to the department early literacy curricula and  
5           instructional materials for use in the following school year in grades kindergarten  
6           to 3. The council on early literacy curricula may recommend only early literacy  
7           curricula and instructional materials that satisfy the following criteria:

8           1. The curricula and instructional materials include all of the components of  
9           science-based early reading instruction.

10          2. The curricula and instructional materials do not include 3-cueing.

11          (b) 1. By no later than 30 days after the department receives recommendations  
12          under par. (a), the department shall submit to the joint committee on finance  
13          proposed recommendations on early literacy curricula and instructional materials  
14          that satisfy the criteria under par. (a) 1. and 2. for use in the following school year.  
15          If the cochairpersons of the joint committee on finance do not notify the department  
16          within 14 working days after the date of the submittal of the proposed  
17          recommendations that the committee has scheduled a meeting to review the  
18          proposed recommendations, the department shall adopt the proposed  
19          recommendations for use in the following school year. If, within 14 working days  
20          after the date of the submittal of the proposed recommendations, the cochairpersons  
21          of the committee notify the department that the committee has scheduled a meeting  
22          to review the proposed recommendations, the department may not adopt the  
23          proposed recommendations unless the committee approves or modifies the proposed  
24          recommendations. If the committee modifies the plan, the department may adopt  
25          the recommendations only as modified by the committee.

1           2. The department shall maintain on its website a current list of the early  
2 literacy curricula and instructional materials recommendations adopted under this  
3 paragraph.

4           (c) The department shall award grants to reimburse school boards, operators  
5 of charter schools, and governing bodies of private schools participating in a program  
6 under s. 118.60 or 119.23 that adopt a literacy curriculum from the recommendations  
7 adopted under par. (b) after January 1, 2024. A grant under this paragraph shall be  
8 an amount equal to one-half of the costs of purchasing the literacy curriculum and  
9 instructional materials adopted from the recommendations adopted under par. (b).  
10 If the amount appropriated for this purpose is insufficient to pay the full amount to  
11 all grant recipients under this paragraph, the department shall prorate the grant  
12 awards among all grant recipients.

13           (d) Beginning on the effective date of this paragraph .... [LRB inserts date], no  
14 school board, operator of a charter school, or governing body of a private school  
15 participating in a program under s. 118.60 or 119.23 may purchase curricula or  
16 instructional materials that include 3-cueing.

17           **SECTION 13.** 118.015 (2) of the statutes is amended to read:

18           118.015 (2) EMPLOYMENT OF READING SPECIALISTS. Each school district shall  
19 employ a reading specialist certified by the department to develop and coordinate a  
20 comprehensive reading curriculum in grades kindergarten to 12. At the discretion  
21 of the state superintendent, a school district may contract with other school districts  
22 or cooperative educational service agencies to employ a certified reading specialist  
23 on a cooperative basis.

24           **SECTION 14.** 118.015 (3) (a) of the statutes is amended to read:

1           118.015 (3) (a) ~~Develop and implement~~ Implement a reading curriculum in  
2 grades kindergarten to 12.

3           **SECTION 15.** 118.015 (5) of the statutes is created to read:

4           118.015 (5) PROHIBITED INSTRUCTIONAL PRACTICES; 3-CUEING. Beginning in the  
5 2024-25 school year, no public school, including a charter school, or private school  
6 participating in a program under s. 118.60 or 119.23 may provide instruction that  
7 incorporates 3-cueing in the core reading curriculum for grades kindergarten to 3  
8 or in supplemental materials, including materials used for reading intervention, for  
9 pupils in grades kindergarten to 3.

10          **SECTION 16.** 118.016 of the statutes is repealed and recreated to read:

11          **118.016 Reading readiness assessments; characteristics of dyslexia.**

12          **(1) DEFINITIONS.** In this section:

13           (a) “At-risk” means a pupil scored below the 25th percentile on a universal  
14 screening assessment or diagnostic assessment, as indicated by the publisher of the  
15 assessment.

16           (b) “Diagnostic assessment” means a tool that includes all of the following:

17           1. An assessment that evaluates a pupil’s skill in the areas listed in par. (L) 1.  
18 to 5., rapid naming, phonological awareness, word recognition, spelling, vocabulary,  
19 listening comprehension, and, when developmentally appropriate for the pupil, oral  
20 reading fluency and reading comprehension.

21           2. An opportunity for a pupil’s parent to complete a family history survey to  
22 provide additional information about learning difficulties in the pupil’s family.

23           (c) “Dyslexia” means a specific learning disability that is all of the following:

24           1. Neurobiological in origin.

1           2. Characterized by difficulties with accurate and fluent word recognition and  
2           poor spelling and decoding abilities that typically result from a deficit in the  
3           phonological component of language. Consequences of these difficulties may include  
4           problems in reading comprehension and reduced reading experience that may  
5           impede vocabulary growth and background knowledge.

6           3. Often unexpected in relation to other cognitive abilities.

7           (d) “Family history survey” means a questionnaire that includes questions  
8           about previous recommendations for summer reading support or outside tutoring,  
9           general interest in reading and books, family history of characteristics of dyslexia,  
10          and any known family struggles in reading or spelling.

11          (e) “Fidelity” means to perform in the manner that the author or publisher of  
12          a program or assessment intends.

13          (f) “Fundamental skills screening assessment” means an assessment that  
14          evaluates whether a pupil possesses phonemic awareness and letter sound  
15          knowledge.

16          (g) “Inadequate rate of progress” means a pupil’s rate of improvement that is  
17          minimal and that with continued intervention the pupil is unlikely to demonstrate  
18          grade-level skills by the end of the school year.

19          (h) “Independent charter school” means a charter school established under s.  
20          118.40 (2r) or (2x).

21          (i) “Intervention” means an intervention that is all of the following:

22           1. Explicit, direct instruction that is systematic, sequential, and cumulative  
23           and follows a logical plan of presenting the area of deficit that targets the specific  
24           needs of the pupil without presuming prior skills or knowledge of the pupil.

1           2. Individualized instruction to meet the specific needs of a pupil in a setting  
2 that uses intensive, highly concentrated instruction methods and materials that  
3 maximize pupil engagement.

4           3. Instruction that incorporates the simultaneous use of 2 or more sensory  
5 pathways during teacher presentations and pupil practice.

6           (j) “Parent” has the meaning given in s. 115.76 (12) (a).

7           (k) “Reading readiness assessment” means a fundamental skills screening  
8 assessment, universal screening assessment, or diagnostic assessment.

9           (L) “Universal screening assessment” means an assessment that evaluates a  
10 pupil’s skill in all of the following areas:

11           1. Phonemic awareness.

12           2. Decoding skills.

13           3. Alphabet knowledge.

14           4. Letter sound knowledge.

15           5. Oral Vocabulary.

16           **(2) FOUR-YEAR-OLD KINDERGARTEN; SCREENING REQUIREMENT.** Each school board  
17 and the operator of each independent charter school shall annually assess the early  
18 literacy skills of each pupil enrolled in 4-year-old kindergarten in the school district  
19 or in the independent charter school at least 2 times during the school year using a  
20 fundamental skills screening assessment selected by the department. The school  
21 board or operator of the independent charter school shall ensure that the first  
22 screening assessment is administered before the 45th day after the first day of the  
23 school term and that the 2nd screening assessment is administered by the date that  
24 is 45 days before the last day of the school term. The school board or operator of the

1 independent charter school shall ensure that assessments required under this  
2 subsection are administered with fidelity.

3 **(3) EARLY LITERACY ASSESSMENTS; 5-YEAR-OLD KINDERGARTEN TO 3RD GRADE.** Each  
4 school board and the operator of each independent charter school shall annually  
5 assess the early literacy skills of each pupil enrolled in 5-year-old kindergarten to  
6 3rd grade in the school district or in the independent charter school as follows:

7 (a) *Universal screenings.* Screen the pupil at least 3 times during the school  
8 year using a universal screening assessment selected by the department. The school  
9 board or operator of the independent charter school shall ensure that the universal  
10 screening assessments are administered at the following times during the school  
11 year:

12 1. The first universal screening assessment is administered before the 45th day  
13 after the first day of the school term.

14 2. The 2nd universal screening assessment is administered in the middle of the  
15 school term, as determined by the school board or operator of the independent  
16 charter school.

17 3. The 3rd universal screening assessment is administered by the date that is  
18 45 days before the last day of the school term.

19 (b) *Diagnostic assessment.* Assess a pupil using a diagnostic assessment as  
20 follows:

21 1. No later than the 2nd Friday of November if a universal screening  
22 assessment administered under par. (a) 1. indicates that the pupil is at-risk.

23 2. Within 10 days after a universal screening assessment is administered  
24 under par. (a) 2. if the universal screening assessment indicates that the pupil is  
25 at-risk.

1           3. Within 20 days after a teacher or parent who suspects that the pupil has  
2 characteristics of dyslexia submits a request for a diagnostic assessment.

3           (c) *Administering assessments with fidelity.* Ensure that each assessment  
4 required under this subsection is administered with fidelity.

5           **(4) PARENTAL NOTIFICATION.** (a) *Assessment results.* A school board or operator  
6 of an independent charter school shall provide the results of a reading readiness  
7 assessment, in writing, to a pupil's parent no later than 15 days after the reading  
8 readiness assessment is scored. For purposes of providing results of a reading  
9 readiness assessment under this paragraph, a school board or operator of an  
10 independent charter school shall provide at least all of the following to a pupil's  
11 parent in the native language of the pupil's parent:

12           1. The pupil's score on the reading readiness assessment.

13           2. The pupil's score in each early literacy skill category assessed by the reading  
14 readiness assessment.

15           3. The pupil's percentile rank score on the reading readiness assessment, if  
16 available.

17           4. The definition of "at-risk" and the score on the reading readiness assessment  
18 that would indicate that a pupil is at-risk.

19           5. A plain language description of the literacy skills the reading readiness  
20 assessment is designed to measure.

21           (b) *Special education information.* If a diagnostic assessment indicates that a  
22 pupil is at-risk, a school board or operator of an independent charter school shall  
23 include information about how to make a special education referral under s. 115.777  
24 with the diagnostic assessment results provided to the parent under par. (a).



1           (c) *Dyslexia information; certain pupils.* If a school board or operator of an  
2 independent charter school is required to assess a pupil's early literacy skills using  
3 a diagnostic assessment, a school board or operator of an independent charter school  
4 shall provide all of the following, in writing, to the pupil's parent:

5           1. A description of the common indicators and characteristics of dyslexia.

6           2. Information about appropriate interventions and accommodations for pupils  
7 with characteristics of dyslexia.

8           (d) *Early literacy remediation plan; availability.* A school board or operator of  
9 an independent charter school shall post its early literacy remediation plan, as  
10 established under sub. (6), on the school district's or independent charter school's  
11 website.

12           **(5) INTERVENTIONS; AT-RISK PUPILS.** (a) *Personal reading plans.* If a pupil  
13 enrolled in 5-year-old kindergarten to 3rd grade is identified as at-risk based on a  
14 universal screening assessment or diagnostic assessment, the school board of the  
15 school district or operator of the independent charter school in which the pupil is  
16 enrolled shall do all of the following:

17           1. Create a personal reading plan for the pupil that includes at least all of the  
18 following:

19           a. The pupil's specific early literacy skill deficiencies, as identified by the  
20 applicable assessment.

21           b. Goals and benchmarks for the pupil's progress toward grade-level literacy  
22 skills.

23           c. How the pupil's progress will be monitored.

1           d. A description of the interventions and any additional instructional services  
2 that will be provided to the pupil to address the pupil's early literacy skill  
3 deficiencies.

4           e. The programming using science-based early reading instruction, as defined  
5 in s. 118.015 (1c) (b), that the pupil's teacher will use to provide reading instruction  
6 to the pupil, addressing the areas of phonemic awareness, phonics, fluency,  
7 vocabulary, and comprehension.

8           f. Strategies the pupil's parent is encouraged to use to help the pupil achieve  
9 grade-level literacy skills.

10          g. Any additional services available and appropriate to accelerate the pupil's  
11 early literacy skill development.

12           2. Provide the interventions described in the pupil's personal reading plan to  
13 the pupil, as soon as practicable.

14           3. Monitor the pupil's progress at least weekly using the method described in  
15 the pupil's personal reading plan to determine whether the pupil demonstrates an  
16 inadequate rate of progress.

17           4. Provide a copy of the pupil's personal reading plan to the pupil's parent and  
18 obtain a copy of the pupil's personal reading plan signed by the pupil's parent.

19           5. After providing the interventions described in the pupil's personal reading  
20 plan to the pupil for 10 weeks, notify the pupil's parent of the pupil's progress, as  
21 determined under the pupil's personal reading plan.

22           (b) *Deadlines for plan creation.* If a school board or operator of an independent  
23 charter school is required to create a personal reading plan for a pupil under par. (a)  
24 1., the school board or operator shall prepare the personal reading plan as follows:

1           1. If the pupil is identified as at-risk based on a universal screening assessment  
2 administered under sub. (3) (a) 1. or based on a diagnostic assessment administered  
3 under sub. (3) (b) 1., no later than the 3rd Friday of November.

4           2. If the pupil is identified as at-risk based on a universal screening assessment  
5 administered under sub. (3) (a) 2. or 3. or based on a diagnostic assessment  
6 administered under sub. (3) (b) 2. or 3., within 10 days after the applicable screening  
7 assessment is administered.

8           (c) *Inadequate rate of progress.* For purposes of determining whether a pupil  
9 demonstrates an inadequate rate of progress under par. (a) 3., a school board or  
10 operator of an independent charter school shall determine whether the pupil is likely  
11 to demonstrate grade-level skills by the end of the school year by assessing one of  
12 the following:

13           1. For a pupil enrolled in 5-year-old kindergarten, nonword or nonsense word  
14 fluency and phoneme segmentation fluency.

15           2. For a pupil enrolled in 1st, 2nd, or 3rd grade, oral reading fluency.

16           **(6) EARLY LITERACY REMEDIATION PLAN; SCHOOL DISTRICT OR INDEPENDENT CHARTER**  
17 **SCHOOL.** A school board or operator of an independent charter school shall establish  
18 an early literacy remediation plan for grades 5-year-old kindergarten to 3 that  
19 includes all of the following:

20           (a) The assessments the school board or operator of the independent charter  
21 school uses to satisfy the requirements under sub. (3).

22           (b) A description of the interventions the school board or operator of the  
23 independent charter school uses to address characteristics of dyslexia.

24           (c) A description of how the school board or operator of the independent charter  
25 school monitors pupil progress during interventions, including the frequency of

1 monitoring pupil progress during interventions and any assessment tools used to  
2 monitor pupil progress during interventions.

3 (d) How the school board or operator of the independent charter school uses  
4 results of assessments required under sub. (3) to evaluate early literacy instruction  
5 being provided in the school district or at the independent charter school.

6 (e) A parent notification policy that complies with subs. (4) and (5) (a) 4. and  
7 5.

8 **(7) REPORTING ASSESSMENT DATA.** By no later than July 15, 2025, and each July  
9 15 thereafter, a school board shall report for each school and for the school district,  
10 and the operator of an independent charter school shall report for the independent  
11 charter school, all of the following to the department:

12 (a) The number of pupils who were identified as at-risk as the result of a  
13 fundamental skills screening assessment administered in the previous school year.

14 (b) The number of pupils who were identified as at-risk as the result of a  
15 universal screening assessment administered in the previous school year.

16 (c) The number of pupils who were identified as at-risk as the result of a  
17 diagnostic assessment administered in the previous school year.

18 (d) The names of the diagnostic assessments used to assess pupils in the  
19 previous school year.

20 (e) The number of pupils enrolled in 5-year-old kindergarten to 3rd grade who  
21 began receiving interventions during the previous school year, by grade.

22 (f) The total number of pupils enrolled in 5-year-old kindergarten to 3rd grade  
23 who received interventions under a personal reading plan during the previous school  
24 year.

1 (g) The number of pupils enrolled in 5-year-old kindergarten to 3rd grade who  
2 exited interventions during the previous school year, by grade.

3 (h) The number of pupils for whom a referral under s. 115.777 was made during  
4 the previous school year based on diagnostic assessment results provided to a parent  
5 under sub. (4) (a).

6 **(8) DEPARTMENT; DUTIES.** (a) *Selected and approved reading readiness*  
7 *assessments.* 1. By no later than July 15, 2024, and subject to subd. 2., the  
8 department shall select a fundamental skills screening assessment and a universal  
9 screening assessment, and establish and maintain a list of diagnostic assessments  
10 that are approved by the department for use under this section.

11 2. The department may select or approve an assessment under subd. 1. only  
12 if the assessment meets all of the following criteria:

13 a. The assessment has a sensitivity rate of at least 70 percent.

14 b. The assessment has a specificity rate of at least 80 percent.

15 c. The assessment includes a growth measure.

16 3. The department shall publish a list of the assessments selected or approved  
17 under subd. 1. on its website and submit the lists of approved assessments to the  
18 appropriate standing committees of the legislature under s. 13.172 (3). If the  
19 department modifies a list under subd. 1., the department shall submit the modified  
20 list to the appropriate standing committees of the legislature under s. 13.172 (3).

21 (b) *Reports to the legislature.* By November 30, 2025, and by each November  
22 30 thereafter, the department shall compile the information it receives under sub.  
23 (7) and submit a report to the appropriate standing committees of the legislature  
24 under s. 13.172 (3) that includes the number of pupils identified as at-risk in the  
25 previous school year, by school and by school district.

1           **(9) STATE AID.** (a) *Payment for costs.* From the appropriation under s. 20.255  
2 (1) (f) and subject to par. (b), the department shall pay a school board or operator of  
3 an independent charter school the per pupil cost of each reading readiness  
4 assessment required to be administered under sub. (2) or (3). Beginning in the  
5 2025-26 school year, the department may pay a school board or operator of an  
6 independent charter school under this paragraph only if the school board or operator  
7 of the independent charter school does all of the following:

8           1. Submits the report required under sub. (7) for the previous school year.

9           2. In the report required under sub. (7) for the previous school year, indicates  
10 that the school board or operator of the independent charter school used only reading  
11 readiness assessments selected or approved under sub. (8) (a) for that school year.

12           (b) *Proration.* If the appropriation under s. 20.255 (1) (f) in any fiscal year is  
13 insufficient to pay the full amount of aid under par. (a), the department shall prorate  
14 state aid payments among the school boards and operators of independent charter  
15 schools entitled to the aid.

16           **(10) ENFORCEMENT.** (a) If a parent or guardian of a pupil enrolled in 4-year-old  
17 kindergarten to 3rd grade in a school district or independent charter school believes  
18 that the school board or operator of the independent charter school is not in  
19 compliance with this section, the parent or guardian may file a complaint with the  
20 department that describes the specific manner in which the school board or operator  
21 is not in compliance with this section. The department shall review a complaint  
22 received under this paragraph and issue a determination on whether the school  
23 board or operator is in compliance with this section. If the department determines  
24 that a school board or operator of an independent charter school is not in compliance

20 (b) *Staggered terms.* Notwithstanding the length of terms specified for the

8 principals, administrators, and literacy teams.

9           b. The provider demonstrates that the training content is aligned with the  
10 National Reading Panel Report and subsequent updates of the research by the  
11 Institute of Education Sciences.

12           c. The provider requires that training include a substantial focus and  
13 understanding on direct instruction.

14           d. The provider delivers the training over at least 6 days during the 2023-24  
15 or 2024-25 school year.

16           e. The provider provides participants with activities to implement  
17 evidence-aligned systems and structures that effectuate change in the school or  
18 school district.

19           f. The provider delivers training that allows for a minimum of 30 participants.

20           (b) The Board of Regents of the University of Wisconsin System shall ensure  
21 that, by July 1, 2025, any faculty or academic staff member of the University of  
22 Wisconsin System who teaches a course that includes curriculum in reading  
23 instruction designed for an individual who intends to apply for a license issued by  
24 the department of public instruction to teach a grade from kindergarten to 3, to be

1 a principal, or to be a reading specialist has received the professional development  
2 training specified in par. (a) 1. and 2.

3 (3) MODEL 3RD GRADE RETENTION POLICY; RULE MAKING.

4 (a) Notwithstanding s. 227.135 (2), the department of public instruction is not  
5 required to present the statement of scope of the rules required under s. 118.33 (5m)  
6 to the department of administration for review by the department of administration  
7 and approval by the governor.

8 (b) Notwithstanding s. 227.185, the department of public instruction is not  
9 required to present the rules required under s. 118.33 (5m) in final draft form to the  
10 governor for approval.

11 (c) Sections 227.137, 227.139, and 227.19 (5) (b) 3. do not apply to the rules  
12 required under s. 118.33 (5m).

13 (d) The department of public instruction shall submit in proposed form the  
14 rules required under s. 118.33 (5m) to the legislative council staff under s. 227.15 (1)  
15 no later than the first day of the 7th month beginning after the effective date of this

22 (e) first applies to the school district and school accountability report published in the
