**SENATE AMENDMENT 8,  
TO SENATE BILL 330**

June 14, 2023 – Offered by Senators LARSON, ROYS, WIRCH, L. JOHNSON, SMITH,  
AGARD, HESSELBEIN and CARPENTER.

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 3, line 13: after that line insert:

3 **“SECTION 2d.** 115.7915 (4m) (em) of the statutes is created to read:

4 115.7915 (4m) (em) Notwithstanding pars. (a), (cm), and (e), if a child attending  
5 a private school under the scholarship program under this section withdraws from  
6 the private school under this section during a school year and enrolls in a school  
7 district, the department shall pay the remainder of the scholarship amount due to  
8 the private school for the child for that school year to the school district in which the  
9 child enrolls.”.

10 **2.** Page 4, line 14: after that line insert:

11 **“SECTION 4d.** 118.40 (2r) (e) 3n. of the statutes is created to read:

12 118.40 (2r) (e) 3n. Notwithstanding subd. 2p., if a pupil attending a charter  
13 school established by or under a contract with an entity under par. (b) 1. for whom

1 a payment is due under this paragraph withdraws from the charter school during the  
2 school year and enrolls in a school district, the department shall pay any remaining  
3 amount due to the operator for that pupil for that school year to the school district  
4 in which the pupil enrolls.

5 **SECTION 4f.** 118.40 (2x) (e) 3. of the statutes is created to read:

6 118.40 (2x) (e) 3. Notwithstanding subd. 1m., if a pupil attending a charter  
7 school established under this subsection for whom a payment is due under this  
8 paragraph withdraws from the charter school during the school year and enrolls in  
9 a school district, the department shall pay any remaining amount due to the operator  
10 for that pupil for that school year to the school district in which the pupil enrolls.”.

11 **3.** Page 7, line 25: after that line insert:

12 **“SECTION 10d.** 118.60 (4) (d) of the statutes is created to read:

13 118.60 (4) (d) Notwithstanding par. (bg), if a pupil attending a private school  
14 under this section for whom a payment is due under this subsection withdraws from  
15 the private school during the school year and enrolls in a school district, the  
16 department shall pay any remaining amount due to the private school for that pupil  
17 for that school year to the school district in which the pupil enrolls.”.

18 **4.** Page 11, line 11: after that line insert:

19 **“SECTION 16d.** 119.23 (4) (d) of the statutes is created to read:

20 119.23 (4) (d) Notwithstanding par. (bg), if a pupil attending a private school  
21 under this section for whom a payment is due under this subsection withdraws from  
22 the private school during the school year and enrolls in a school district, the

1 department shall pay any remaining amount due to the private school for that pupil  
2 for that school year to the school district in which the pupil enrolls.”.
