**SENATE AMENDMENT 4,
TO SENATE BILL 571**

February 1, 2024 - Offered by Senator CABRAL-GUEVARA.

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 3, line 2: after “institution” insert “or material created for the
3 institution or a college, school, department, or functional equivalent of the
4 institution by a student acting on behalf of or in conjunction with an employee of the
5 institution to produce material for institutional purposes and for which the employee
6 is responsible. “Institution-sponsored media” includes yearbooks.”.

7 **2.** Page 3, line 23: after “law” insert “, including a violation of s. 948.11 or
8 copyright law”.

9 **3.** Page 4, line 3: after that line insert:

10 “6. Rejected by a student-editor or an all-student editorial board.”.

11 **4.** Page 5, line 9: after “media” insert “or, for an institution that imposes no
12 such limitations, a statement to that effect”.

1 **5.** Page 5, line 10: after “section” insert “, except that this paragraph does not
2 apply for an institution that demonstrates to the board that only students are
3 involved in making editorial or publication decisions”.

4 **6.** Page 6, line 4: after “college” insert “or material created for the technical
5 college or a school, department, or functional equivalent of the technical college by
6 a student acting on behalf of or in conjunction with an employee of the technical
7 college to produce material for the technical college’s purposes and for which the
8 employee is responsible. “District board–sponsored media” includes yearbooks.”.

9 **7.** Page 6, line 25: after “law” insert “, including a violation of s. 948.11 or
10 copyright law”.

11 **8.** Page 7, line 3: after that line insert:

12 “6. Rejected by a student–editor or an all–student editorial board.”.

13 **9.** Page 8, line 9: after “media” insert “or, if the district board imposes no such
14 limitations, a statement to that effect”.

15 **10.** Page 8, line 10: after “section” insert “, except that this paragraph does not
16 apply if the district board demonstrates to the board that only students are involved
17 in making editorial or publication decisions”.

18 **11.** Page 9, line 4: delete “6” and substitute “9”.

19 **12.** Page 9, line 7: delete “middle, junior high, or”.

20 **13.** Page 9, line 13: after “purposes.” insert ““School–sponsored media”
21 includes yearbooks.”.

22 **14.** Page 10, line 3: after “law” insert “, including a violation of s. 948.11 or
23 copyright law”.

1 **15.** Page 10, line 6: after that line insert:

2 “6. Rejected by a pupil-editor or an all-pupil editorial board.”.

3 **16.** Page 10, line 14: after that line insert:

4 “(d) A minor pupil may participate in producing school-sponsored media only
5 if the school obtains the written consent of the pupil’s parent or guardian on a consent
6 form adopted under sub. (6) (c).”.

7 **17.** Page 11, line 12: after “media” insert “or, for a school board or charter
8 school operator that imposes no such limitations, a statement to that effect”.

9 **18.** Page 11, line 13: after “section” insert “, except that this paragraph does
10 not apply if the school board or charter school operator demonstrates to the
11 department that only pupils are involved in making editorial or publication
12 decisions”.

13 **19.** Page 11, line 13: after that line insert:

14 “(c) A consent form that includes a description of the rights and responsibilities
15 described under this section.”.
