***Analysis by the Legislative Reference Bureau***

Under current law, the only subject that most state and municipal employees may collectively bargain over is a percentage increase in base wages that does not exceed the percentage increase in the consumer price index. This bill removes that limitation so that state and municipal employees may bargain over any increase in wages.

Also, under current law, certain protective occupation participants under the Wisconsin Retirement System, known as public safety employees, and certain municipal transit employees may collectively bargain wages, hours, and conditions of employment. Under the bill, most state and general municipal employees may collectively bargain hours and conditions of employment.

The bill also allows all municipal employers and labor organizations to agree to a dispute settlement procedure, including binding interest arbitration, to resolve an impasse over the terms of a collective bargaining agreement under the Municipal Employment Relations Act.

Under current law, representatives for most municipal and state employee bargaining units must be selected by at least 51 percent of the employees in the bargaining unit. The bill changes that requirement to a simple majority of the employees voting in the collective bargaining unit.

Finally, under current law, representatives for most municipal and state employee bargaining units must be certified annually by receiving at least 51 percent of the vote of the employees in the bargaining unit. The bill repeals this certification requirement.

3 compliance would tend to result in a settlement, it may order compliance before  
4 ordering arbitration. The validity of any arbitration award or collective bargaining  
5 agreement is not affected by failure to comply with the procedures. Prior to the close  
6 of the investigation, each party shall submit in writing to the commission its single  
7 final offer containing its final proposals on all issues in dispute that are subject to

18 jurisdiction to provide the opportunity to both parties to explain or present  
19 supporting arguments for their positions and to members of the public to offer their  
20 comments and suggestions. The final offers of the parties, as transmitted by the  
21 commission to the arbitrator, are the basis for any continued negotiations between  
22 the parties with respect to the issues in dispute. At any time prior to the arbitration  
23 hearing, either party, with the consent of the other party, may modify its final offer  
24 in writing.

1           c. Prior to the arbitration hearing, either party may, within a time limit  
2 established by the arbitrator, withdraw its final offer and any mutually agreed upon  
3 modifications and shall immediately provide written notice of any withdrawal to the  
4 other party, the arbitrator, and the commission. If both parties withdraw their final  
5 offers and mutually agreed upon modifications, the labor organization, after giving  
6 10 days' written notice to the municipal employer and the commission, may strike.  
7 Unless both parties withdraw their final offers and mutually agreed upon  
8 modifications, the final offer of neither party is considered withdrawn and the  
9 arbitrator shall proceed to resolve the dispute by final and binding arbitration as  
10 provided in this paragraph.

11           d. Before issuing his or her arbitration decision, the arbitrator shall, on his or  
12 her own motion or at the request of either party, conduct a meeting open to the public  
13 to provide to both parties the opportunity to explain or present supporting  
14 arguments for their complete offer on all matters to be covered by the proposed  
15 agreement. The arbitrator shall adopt without modification the final offer of one of  
16 the parties on all disputed issues submitted under subd. 6. am., except those items  
17 that the commission determines not to be mandatory subjects of bargaining and  
18 those items that have not been treated as mandatory subjects by the parties, and  
19 including any prior modifications of the offer mutually agreed upon by the parties  
20 under subd. 6. b. The decision is final and binding on both parties and shall be  
21 incorporated into a written collective bargaining agreement. The arbitrator shall  
22 serve a copy of his or her decision on both parties and the commission.

23           e. Arbitration proceedings may not be interrupted or terminated by reason of  
24 any prohibited practice complaint filed by either party at any time.

1 f. The parties shall equally divide the costs of arbitration. The arbitrator shall  
2 submit a statement of his or her costs to both parties and to the commission.

3 g. If a question arises as to whether any proposal made in negotiations by either  
4 party is a mandatory, permissive, or prohibited subject of bargaining, the  
5 commission shall determine the issue under par. (b). If either party to the dispute  
6 petitions the commission for a declaratory ruling under par. (b), the proceedings  
7 under subd. 6. c. and d. may not occur until the commission renders a decision in the  
8 matter and the decision is final. The arbitrator's award shall be made in accordance  
9 with the commission's ruling, subject to automatic amendment by any subsequent  
10 court reversal.

19 accounting of the consideration of this factor in the decision.

7 a. The lawful authority of the municipal employer.

8 b. Stipulations of the parties.

9 c. The interests and welfare of the public and the financial ability of the unit  
10 of government to meet the costs of any proposed settlement.

11 d. Comparison of wages, hours, and conditions of employment of the municipal  
12 employees involved in the arbitration proceedings with the wages, hours, and  
13 conditions of employment of other employees performing similar services.

14 e. Comparison of the wages, hours, and conditions of employment of the  
15 municipal employees involved in the arbitration proceedings with the wages, hours,  
16 and conditions of employment of other employees generally in public employment in
