




ORDER OF THE STATE OF WISCONSIN NATURAL RESOURCES BOARD AMENDING RULES

The Wisconsin Natural Resources Board . adopts an order to amend NR 24.09 (1) (a) . FH-26-97 and (2), as affected by Clearinghouse Rule . 96-189, relating to commercial clamming . on the Wisconsin-Iowa boundary waters .

Analysis Prepared by Department of Natural Resources

Statutory authority: ss. 29.085, 29.38 (8) (a) and (e) and 227.11 (2) (a), Stats.

Statutes interpreted: ss. 29.085 and 29.38 (1) and (8), Stats.

SECTION 1. removes washboard clams, Megalonaias gigantea, from the list of open species available for harvest on the Wisconsin-Iowa boundary waters beginning with the 1998 harvest season.

In light of SECTION 1., SECTION 2. deletes washboard clams from the size limits for cooked shell beginning with the 1998 harvest season.

SECTION 2. NR 24.09 (2), as affected by Clearinghouse Rule 96-189, is amended to read:

NR 24.09 (2) Notwithstanding the minimum size limits set in sub. (1), the minimum size for cooked clams shall be 2-1/2" for mapleleaf, pigtoe, and pimpleback clams, and 2-13/16" for threeridge clams and 3-3/4" for washboard clams.




