## Analysis Prepared by the Department of Natural Resources

Statutory authority: ss. 281.12(1), 281.15, 281.19(1) and 299.11, Stats., and ch. 160, Stats.

Statutes interpreted: ss. 281.12(1), 281.15, 281.19(1) and 299.11, Stats., and ch. 160, Stats.

The proposed rule revises the existing state groundwater quality standards for arsenic. The enforcement standard will be lowered from 50 to 10 micrograms per liter and the preventive action limit will be lower from 5 to 1 microgram per liter. In accordance with ch. 160, Stats., enforcement standard groundwater quality standards are established based on recommendations received from the Department of Health and Family Services (DHFS). Preventive action limit groundwater quality standards for substances of public health concern are set at either 20% of the concentration of the established enforcement standard, or at 10% of the concentration of the established enforcement standard if the substance has carcinogenic, mutagenic or teratogenic properties or interactive effects.

DHFS staff review existing regulatory and toxicological information for substances of potential health concern. If a federal number, such as a federal drinking water standard or no-observed-adverse-effect-level, has been established for a substance, this number is used as the recommended ch. NR 140 enforcement standard. In January, 2001 the U.S. EPA established a new federal drinking water maximum contaminant level (MCL) for arsenic of 10 micrograms per liter. In accordance with s. 160.7(4), Stats., the DHFS has recommended adoption of the federal MCL as the NR 140 enforcement standard. Because arsenic is a known carcinogen, an NR 140 preventive action limit of 1 microgram per liter (10% of the recommended 10 microgram per liter enforcement standard) has been proposed.

## SECTION 1. NR 140.10, Table 1 is amended to read:
