Eliminate Diesel Truck Idling Reduction Grant Program (Administration - General Agency Provisions)

[LFB 2017-19 Budget Summary: Page 30, #14]

CURRENT LAW

The Department of Administration (DOA) manages the diesel truck idling reduction grant program, which is scheduled to sunset on June 30, 2020, for grant funds and June 30, 2021, for program administration. Funding for the program is provided from the petroleum inspection fund.

GOVERNOR

Delete \$1,000,000 SEG in 2017-18 and \$1,077,100 SEG and 1.0 SEG position in 2018-19 associated with the diesel truck idling reduction grant program and associated funding and position authority. Eliminate diesel truck idling grants effective June 30, 2017, and specify an end date of June 30, 2018, for program administration.

DISCUSSION POINTS

- 1. The diesel truck idling reduction grant program, created under 2005 Act 25, is administered by DOA's Division of Energy, Housing and Community Resources. The program was originally scheduled to sunset on June 30, 2011, for grants and June 30, 2012, for program administration. The program was extended under 2009 Act 28 and 2015 Act 55.
- 2. The program aims to improve fuel efficiency and lower air pollution by providing grants to freight motor carriers headquartered in Wisconsin to purchase and install idling reduction units for long-haul truck tractors. The idling reduction units provide an alternative source of power

to heat, cool, or provide electricity to the truck cab, or other parts of the vehicle, instead of using the vehicle's main drive engine to power those functions. Motor carriers are eligible to receive reimbursement of up to 50% of the cost to purchase and install idling reduction equipment.

- 3. The grant program, which was provided a five-year extension under the 2015-17 biennial budget act (2015 Act 55), currently has sunset dates of June 30, 2020, for funding of grants and December 31, 2021, for funding of program administration. Funding for the program is \$1,076,200 SEG (\$1.0 million for grants and \$76,200 for administration) and 1.0 SEG position in 2016-17, funded from the segregated petroleum inspection fund. Attachment 1 identifies 2015-16 grants by recipient, size of fleet, headquartered city, and grant amount awarded.
- 4. Revenue for the petroleum inspection fund is primarily generated from the 2¢ per gallon petroleum inspection fee. The Department of Agriculture, Trade and Consumer Protection is responsible for inspecting petroleum products brought in to the state to assure that the product meets minimum product grade and environmental specifications. A petroleum inspection fee is assessed on all of the inspected petroleum products (such as gasoline, diesel, and home heating oil). If the diesel truck idling reduction grant program were eliminated, the funds appropriated for the program would remain in the balance of the petroleum inspection fund and could be used for other purposes of the fund, including debt service payments.
- 5. In its 2017-19 agency budget request, DOA indicated that "Demand for funding under this program remains relatively strong and recipients generally report increased efficiency, cost savings and reduced pollution. However, incorporation of these technologies has become generally accepted by the industry due to their cost effectiveness and proven technologies. Sunsetting the program earlier than provided under current law would not be expected to decrease the industry's use of these technologies."
- 6. The administration argues that the elimination of the grant program will not affect utilization of diesel truck idling reduction technologies. In addition, the budget provision would reduce expenditures from the petroleum inspection fund, allowing revenue from the fund to be used for other purposes. Therefore, the Committee could choose to approve the Governor's recommendation. [Alternative 1]
- 7. On the other hand, the subsidization of diesel idling reduction units through the grant program may have a positive influence on adoption and use of such units in the trucking industry. To the extent that the grant program has an effect on installation of diesel idling reduction units, such that fewer units would be purchased and installed if the program were eliminated, it is possible that the budget provision could result in reduced fuel efficiency and increased air pollution. Additionally, this form of financial assistance would no longer be available to trucking companies. Therefore, the Committee could choose to delete the Governor's recommendation. [Alternative 2]

ALTERNATIVES

1. Approve the Governor's recommendation to delete \$1,000,000 SEG in 2017-18 and \$1,077,100 SEG and 1.0 SEG position in 2018-19 associated with the diesel truck idling reduction

grant program under DOA. Eliminate diesel truck idling grants effective June 30, 2017, and program administration effective June 30, 2018.
