# Increase the Investment Limit for Qualified New Business Ventures (General Fund Taxes -- Income and Franchise Taxes)

[LFB 2017-19 Budget Summary: Page 185, #21]

#### **CURRENT LAW**

The early stage business investment program includes two nonrefundable tax credits: (a) the angel investment credit, which can be claimed under the individual income tax; and (b) the early stage seed investment credit, which can be claimed under the individual income tax, the corporate income/franchise tax, and the insurance premiums tax. For purposes of this paper, the two credits are jointly referred to as "investment credits."

The angel investment tax credit equals 25% of the claimant's bona fide angel investment made directly in a qualified new business venture (QNBV) certified by the Wisconsin Economic Development Corporation (WEDC). The early stage seed investment tax credit is equal to 25% of the claimant's investment paid to a certified fund manager that the fund manager invests in a QNBV. In order for a business to be certified as a QNBV, the business must meet certain statutory criteria such as being headquartered in Wisconsin, having the potential for increasing jobs and/or capital investment in Wisconsin, and being engaged in certain targeted industries. The aggregate amount of investments in any one QNBV that may qualify for investment credits is \$8.0 million (\$2.0 million of investment credits). Investments in a QNBV must be maintained for at least three years. The annual limit on the amount of investment credits that WEDC can verify is \$30 million per calendar year.

Prior to the creation of WEDC in 2011, the investment credits were administered by the Department of Commerce.

#### **GOVERNOR**

Increase the maximum amount of investments that qualify for investment credits that a QNBV can receive, beginning with taxable years starting after December 31, 2016, from \$8.0 million to \$12.0 million (from \$2.0 million of investment credits to \$3.0 million). The administration estimates that this provision would reduce state tax revenue by \$3.2 million in 2017-18 and \$2.2 million in 2018-19 and annually thereafter.

#### **DISCUSSION POINTS**

1. The early stage business investment program was created under 2003 Wisconsin Act 255. A number of legislative acts have modified and expanded the program to its current form. Table 1 shows the amount of investment credits that have been verified by WEDC/Commerce, and the amount of investments that were eligible for the credits since the credits were first available in 2005. Prior to tax year 2008, the angel investment credit was equal to 12.5% of an eligible investment made in a QNBV that could be claimed in both the year the investment was made and the year following when the investment was made (total credit equal to 25% of investment). Investment credit verifications shown for 2016 are preliminary.

As shown in Table 1, the annual amount of investments verified by WEDC/Commerce as eligible for the investment credits grew steadily from \$12.5 million in 2005 to \$35.0 million in 2009 before dropping slightly to \$30.4 million in 2010. The average annual amount of investments verified for credits from 2011 through 2014 was \$44.6 million. In 2015, investments

verified for credits increased to \$73.1 million, and preliminary data shows that WEDC verified a similar amount of credits in 2016.

- 3. When the program was created under Act 255, only the first \$1.0 million of investments made in a QNBV could be eligible for angel investment credits, and Commerce adopted rules that limited the total amount of investments eligible for either of the investment credits to \$4.0 million. The investment limit was statutorily changed to reflect the \$4.0 million limit for tax years 2008, 2009, and 2010, pursuant to 2009 Wisconsin Act 2. In addition, Act 2 increased the investment limit to \$8.0 million beginning in tax year 2011. The investment limit has not since been adjusted.
- 4. WEDC states that the increase in the investment limit is being recommended so that companies with higher investment needs can remain in the program. Certain companies with extended regulatory or approval timelines must raise capital over a longer period of time before their product can be introduced to the market. In addition, WEDC states that another reason to raise the investment limit is that the limit has not been adjusted since 2009.
- 5. Attachment 1 provides information compiled by WEDC regarding investment tax credit programs in other states. Wisconsin in one of 23 states that offers an investment tax credit program. States with similar programs offer credit percentage rates of between 10% and 50% of the investment, but limit state expenditures through those programs in several different ways. Wisconsin offers the highest annual allocation limit among the states at \$30 million, whereas 16 states have annual limits below \$10 million. Most states apply additional limits, such as the amount of revenue a company can earn for investments to be eligible for the credits (12 states), the amount of investments eligible for credits that a company can receive (seven states, including Wisconsin), the maximum amount of credit an investor can earn per year (15 states), and the maximum amount of credit per investment made in a company (one state).
- 6. Wisconsin offers the highest limit among the states that limit the amount of credits that a company can provide to investors at \$2.0 million, whereas three states have a limit of \$1.0 million, one state has a limit of \$250,000, and two states have a limit of \$50,000. Compared to other states with a per-company investment limit, the Governor's recommendation would increase Wisconsin's per company limit from twice the limit compared to other states to three times the limit.
- 7. Since the early stage business investment program took effect, 374 businesses have been certified by WEDC/Commerce as QNBVs. This information is presented in Attachment 2. Companies that are no longer certified as QNBVs or subject to WEDC reporting requirements total 142, of which 55 (39%) never received an investment eligible for an investment credit, one company reached the investment limit, one company received investments eligible for \$1.7 million in credits, and seven other companies received investments eligible for \$1.0 million or more of investments. Among the other 232 businesses, 207 are currently certified as QNBVs and actively raising funds and 25 are no longer certified as QNBVs but are still subject to WEDC reporting requirements on investments they have received. Currently certified QNBVs and companies reporting on investments that are at or near the cap total 11; eight QNBVs have received investments eligible for credits within 25% of the current investment limit; and 14 QNBVs have received investments eligible for between half and 25% the current investment limit.

- 8. The administration estimated that the Governor's recommended increase in the investment limit would reduce state tax revenues by \$3.2 million in 2017-18 and \$2.2 million in 2018-19 and annually thereafter. The estimate provided by the administration was based on an analysis performed by this office two years ago when the Governor recommended this provision in the 2015-17 biennial budget bill. At that time, four businesses were affected by the current investment limit. However, the number of businesses affected by the current investment limit has nearly tripled since that time.
- 9. Based primarily on the information described above, as well as increased verification activity in recent years as shown in Table 1, the fiscal effect of adopting the Governor's recommended increase in the investment limit has been reestimated to reduce state tax revenues by \$5.0 million in 2017-18, \$7.4 million in 2018-19, \$2.4 million in 2019-20, and \$2.0 million in 2020-21. Over the biennium, this provision is estimated to reduce state tax revenues by an additional \$7.0 million compared to the current estimates under the bill.
- 10. The Committee could choose to adopt a different investment limit that is lower than the limit recommended by the Governor (\$12.0 million) and higher than the current law limit (\$8.0 million). Alternative 2 presents the estimated fiscal effect if the Committee chose to adopt an investment limit of \$10.0 million.
- 11. The Committee could also choose to eliminate the provision recommended by the Governor and maintain current law. In order to be initially certified as a QNBV, a company must have less than 100 employees, cannot have received aggregate private equity investment in cash of more than \$10 million, and cannot have been in operation for more than 10 consecutive years at the time of initial certification. However, these limits do not apply to companies as they mature, but continue to recertify as QNBVs. The early stage business investment was enacted to encourage investments in Wisconsin start-up companies. It could be argued that broadening the credits to incentivize continued investment in more mature Wisconsin companies is not the purpose of this program. As noted, Wisconsin currently offers the highest annual limit for investment credits compared to states with similar investment tax credit programs and offers the highest per-company investment limit compared to those states with a similar limit. The Committee could choose to use available general fund revenues for other economic development purposes.

#### **ALTERNATIVES**

1. Adopt the provision recommended by the Governor. Reestimate this provision to reduce state tax revenues by \$5.0 million in 2017-18, \$7.4 million in 2018-19, \$2.4 million in 2019-20, and \$2.0 million in 2020-21.

2. Modify the provision recommended by the Governor to increase the maximum amount

of investments that could qualify for investment credits that a QNBV could receive, beginning with taxable years starting after December 31, 2016, from \$8.0 million to \$10.0 million. Estimate the fiscal effect of this provision to be a reduction in state tax revenues of \$2.5 million in 2017-18, \$3.8 million in 2018-19, \$1.4 million in 2019-20, and \$1.1 million in 2020-21.
