SUBJECT: Regulation and Licensing: Professional and Occupational Credential Fees -- Agenda

Item IX

REQUEST

On January 30, 2009, under the fee setting procedures approved in 2007 Wisconsin Act 20, the Department of Regulation and Licensing (DRL) requested approval of initial and credential renewal fees assessed to occupations and businesses regulated by the Department for the 2009-11 biennium. The proposal was subject to 14-day passive review by the Joint Committee on Finance. An objection to the proposal was received. This proposal is now subject to review under s. 13.10 of the statutes.

The 2009-11 budget, as passed by the Assembly and Senate, would reestablish the initial and renewal fees via statute for 12 professions related to the Medical Examining Board and the attached affiliated credentialing boards (athletic trainers, dieticians, perfusionists, medical doctors, doctors of osteopathy, physician assistants, respiratory care practitioners, occupational therapists, occupational therapist assistants, physical therapists, physical therapist assistants, and podiatrists). These professions are not readdressed under this memorandum.

Attachment 1 (initial credentials) and Attachment 2 (credential renewals) shows the current statutory fees levels, DRL's proposed changes to fees, and the difference between the two fees. Under the request, initial fees would be set at \$75 for most professions (see Appendix 1) and credential renewal fees would vary between \$82 and \$170 (see Appendix 2). It is estimated that these fees would total \$29,279,000 over the biennium, which would include \$26,351,100 PR-REV for agency costs and \$2,927,900 GPR-Earned for deposit into the general fund.

BACKGROUND

Prior to 2007 Act 20, DRL licensing fees were statutorily established. However, as a result of

Act 20 beginning with license applications for the 2009-11 biennium, DRL must set initial and renewal credential fees for occupational and professional credentials administratively. These administratively established fees are not subject to administrative rule procedures. Instead, the revised fees are subject to review by the Joint Committee on Finance.

The Department must send a report to the Co-chairs of Joint Committee on Finance, within 14 days of completing the proposed fee adjustments. The Committee then has 14 working days after the submission of the report to notify the Secretary of the Department of Regulation and Licensing that the Committee has scheduled a meeting for review the proposed adjustments. If notification is not provided by the Committee within 14 days of receiving the report, the proposed fee changes will be approved. Once the fees are approved, the Department must post the fee adjustments on the DRL Internet web site and in credential renewal notices sent to affected credential holders.

The last time fees were changed was in connection with the 2001-03 biennial budget. The Department currently regulates approximately 375,000 credential holders in 128 different occupational areas. Each credential is generally valid for a two-year period.

Initial Credential Fees. Under the DRL's request, the initial fees would be set at \$75 for most professions. The requested fee level was based on the actual costs of issuing initial credentials in fiscal years 2006-07 and 2007-08, plus the statutorily required 10% administrative fee to the general fund, and a portion of contributions to a \$5 million contingency fund which the Department seeks to establish. Cost items include such activities as processing applications and determining eligibility for licensure. Currently, the initial license fee is set by statute at \$53 for most professions. By statute, the Department may not recommend an initial fee that is greater than the renewal fee, unless an examination is required for the initial credential.

Credential Renewal Fees. The credential renewal fees, under the request, would vary between \$82 and \$170 based on the costs of regulating each business or occupation. The minimums and maximums were established by DRL in order to both minimize the subsidization by larger professions and to minimize the fee increases for smaller professions. The renewal fees are based on the costs of administration, enforcement, board services, the Office of Legal Council, credentialing costs, and contributions to a contingency fund. The Department has began to use time distribution data which requires agency personnel to document the amount of time they spend on work related to each business or occupational credential.

Regulation and Licensing is statutorily required to credit 10% of the revenue generated from initial and credential renewal fees, from examinations fees and background investigations to the general fund. Consequently, fees must be set at a level sufficient to fund the agency's administrative and enforcement costs, net of the revenue allocations to the general fund.

ANALYSIS

Under current law, DRL must determine the fee level of each initial credential for which no

examination is required, for reciprocal credentials, and for all credential renewals, based on the administrative costs of the Department that are attributable to the regulation of each occupation or business regulated by the agency. The Department was required to complete this recalculation by January 31, 2009, (and recalculate those figures in each odd-numbered year, for the succeeding fiscal biennia). Current statutes specify that the fees currently set in statute will be deleted, effective July 1, 2009.

It is estimated that the current fee levels (if they were maintained) would generate \$2,356,900 for initial credentials and \$20,645,800 for credential renewals, for a total of \$23,002,700 over the 2009-11 biennium. An estimated \$2,300,300 would be deposited into the general fund as part of the 10% administrative surcharge, while \$20,702,400 would be available for DRL's general program operations. Under 2009 Assembly Bill 75, as passed by the Assembly and Senate, \$19,876,000 PR biennially would be provided for general program operation appropriation authority. The Department would also be required to transfer to the general fund \$1,831,800 biennially as part of 2% general wage adjustments, state employee furloughs and agency reductions of 5.135%. In total, the Department would have to generate revenues of \$21,707,800 over the biennium to support these costs. The Department has estimated that the 2008-09 closing balance will be \$1,379,100.

As shown in Table 1, it is estimated that the current fee structure would not support

appropriation authority plus reserves. In addition, the current fee structure is scheduled to end on July 1, 2009, at which time the fees established by rule would become effective. The Committee could chose to restore the current fee levels for businesses and professions regulated by the Department, in which case the Department would likely have to reduce some of the agency expenditures in order to balance revenues and expenditures.

Ideally, credential holders for each credential type would pay the full costs of regulating their profession. However, the fees have not been adjusted since the 2001-03 biennium and it is likely that the regulation burden has shifted over the last eight years. In addition, the Legislature in recent years has asked the Department to shift from a general analysis of workload per credential type to recording hours worked on specific professions.

In recalculating the costs of regulating different professions and businesses, in most cases, DRL combined the costs of different professions under the same board (such as pharmacists, pharmacies, drug distributors, and drug manufactures) to minimize the impact of fee changes within an individual profession. The professions that are directly regulated by the Department (not under the scope of a credentialing board) were considered to be part of the same general field, although they encompass a wide variety of professions. For these professions, fees would be set at \$107 per biennium.

Attachment 3 shows the estimated revenue for the proposed initial fees compared to current law levels for the 2009-11 biennium. Attachment 4 shows the same information for the renewal fees. It is estimated that the proposed fees would generate \$3,452,000 from initial fees and \$25,827,000 from renewal fees, totaling \$29,279,000 for the 2009-11 biennium for those professions that would be regulated under the general program operations (excluding the fees approved by the Committee for Medical Examining Board-professions in actions on AB 75). The Department must deposit 10% of all credential fees into the general fund (\$2,927,900). After this reduction, \$26,351,100 would be available for the general program operations of the Department. The proposed fees would be an increase of 46.5% for initial credentials and an average of 27.3% for renewals. Therefore, the Department's proposal is estimated to increase total assessments by \$6,276,200 over the biennium for professions regulated by the Department (excluding Medical Examining Board professions).

Table 2 compares the estimated revenues under the proposed fees with potential expenditure levels under the AB 75, as modified by the Assembly and Senate. The table includes reserves for compensation, health insurance, and space rental for a total of \$738,400 biennially.

As shown in the table, it is estimated that there would be revenue reserves of approximately \$3.9 million generated over the 2009-11 biennium if the Department's fee request is approved. Including estimated 2009-10 beginning balances, 2010-11 ending balances would be estimated at \$5.3 million.

In its agency request for the 2009-11 biennium, DRL stated that it wished to establish a \$5 million contingency fund for potential increases in employee-related expenses and any new legislative directives (such as requirements to regulate other professions). It could be noted, that the figure above already includes specific amounts for potential increases to employee related-expenses. In regards to new legislation, such legislation would generally include a review of funding issues and could include additional funding, if necessary. It is more likely that such reserves would be used for transfers to the general fund.

Under the Assembly and Senate versions of the 2009-11 budget, \$500,000 would be provided for supplemental funding, including potential additions to staff for Medical Examining Board administration. The Committee could choose to provide similar biennial reserves for the remaining professions. Under this alternative, the Committee could reduce the proposed fees by 12.8%, which would establish most initial fees at \$65 (Attachment 5), and renewal fees would vary between \$72 and \$148 biennially (Attachment 6). It is estimated that revenues would total \$25,607,100 (Attachment 7), with \$23,046,400 PR available for general program operations of DRL, and \$2,560,700 for deposit into the general fund. Table 3 shows the estimated biennial expenditures, revenues and reserves under this alternative.

Based on previous Committee action on the Medical Examining Board versus base level estimates of GPR-Earned and PR-REV, the amount of revenue earned in either the agency's request or the second alternative can be estimated. If the Committee adopts the agency requested fee levels, the following revenue changes would be anticipated (\$102,800 GPR-Earned and \$3,037,900 PR-REV in 2009-10 and \$438,200 GPR-Earned and \$2,610,700 PR-REV in 2010-11). If the Committee adopted the second alternative the following revenue changes would be expected (-\$65,400 GPR-Earned and \$1,523,700 PR-REV in 2009-10 and \$239,300 GPR-Earned and \$820,500 PR-REV in 2010-11).

ALTERNATIVES

- 1. Approve the Department of Regulation and Licensing's proposal for initial and renewal credential fees as shown in Attachments 1 and 2. Reestimate revenues by \$102,800 GPR-Earned and \$3,037,900 PR-REV in 2009-10 and \$438,200 GPR-Earned and \$2,610,700 PR-REV in 2010-11.
- 2. Specify initial and renewal credential fees as shown in Attachments 5 and 6. Reestimate revenues by -\$65,400 GPR-Earned and \$1,523.700 PR-REV in 2009-10 and \$239,300 GPR-Earned and \$820,500 PR-REV in 2010-11.
