SUBJECT: Transportation: Governor's Section 13.10 Request for Use of Federal Economic

Stimulus Funding for Local and State Transportation Projects -- Agenda Item V

REQUEST

The Governor requests approval of the use of federal funds received under transportation provisions of the federal American Recovery and Reinvestment Act of 2009 (federal economic stimulus act) as follows for projects to be let in 2010: (a) \$4,248,700 for nine transportation enhancement projects (see Attachment 1); (b) \$53,236,600 for 66 local road and bridge projects (see Attachment 2); and (c) \$35,088,600 for ten state highway bridge projects (see Attachment 3).

BACKGROUND

The State of Wisconsin will receive a total of \$529.1 million in funds under the federal economic stimulus act. Under 2009 Act 2, \$300.0 million of this total was allocated to state highway and bridge projects. Committee action on three previous requests (on March 17, May 12, and June 30, 2009) allocated \$158.7 million for local road and bridge projects and \$15.9 million for transportation enhancement projects. Following these approvals, a total of \$54.5 million remained to be allocated. Since that time, the Department of Transportation (DOT) has begun to let projects to contract and has realized let savings (bids below project cost estimates) totaling \$20.9 million. When combined with the previously unallocated funds, there is currently \$75.4 million available for additional projects.

ANALYSIS

The projects included in this request are located in economically distressed areas, as designated by the federal government. The following table indicates which counties in Wisconsin are included in such areas.

For the purpose of this request, DOT contacted local governments in these areas to determine if previously submitted projects that had not been selected for earlier requests could be accomplished within the timetables established in the federal economic stimulus act. This request includes all 75 of the local projects identified using this process. The request also includes ten state projects located within economically distressed areas.

The total estimated cost of the projects included in this request is \$92.6 million. This exceeds available funding by \$17.2 million. The request identifies three reasons why it may be desirable to "over program" the use of federal economic stimulus funds. First, it is possible that additional let savings will be realized as DOT receives bids on the remaining projects. Second, as projects are advanced, it may not be possible for all of them to meet the federally-required timetable. Third, earlier approval of "excess" projects ensures that other projects are available within the federal timetable to fully utilize federal funds made available through let savings or project delays. Waiting until these events occur to approve new projects may result in too little time to move these projects forward by the federal deadlines. Another potential advantage of approving more projects now is that the state would be well-positioned to compete for any federal economic stimulus funding that other states cannot use by the deadlines.

The request indicates that priority will be given to funding all of the local projects, which total \$57.5 million, which is \$17.9 million less than the total available funding. Therefore, the state projects would serve as the flexible portion of the request, with \$17.9 million being initially

available for \$35.1 million in projects. Any part of the remaining \$17.2 million that cannot be funded with economic stimulus dollars made available by let savings, delays in other projects, or redistributions from other states would be funded through the state's regular appropriations for the state highway program.

ALTERNATIVES

- 1. Approve the Governor's request for the following: (a) \$4,248,700 for nine transportation enhancement projects; (b) \$53,236,600 for 66 local road and bridge projects; and (c) \$35,088,600 for ten state highway and bridge projects.
 - 2. Deny the request.
