SUBJECT: Safety and Professional Services 2015-17 Credential Fee Proposal -- Agenda Item IV

On January 26, 2015, the Department of Safety and Professional Services (DSPS) submitted its 2015-17 credential fee proposal to the Committee. The Committee notified the Department that an objection had been filed under the 14-day passive review process.

#### **Cost Allocation Study**

Under s. 440.03(9) of the statutes, DSPS is required to conduct a study of the cost of licensing and regulating each profession every two years in order to determine the fee levels for that biennium. DSPS uses a cost allocation study to determine the cost of regulating each profession, which is based on workload data maintained by DSPS staff who report the total time they spend on activities related to each profession. In addition, certain central staff, supplies, and services costs are allocated evenly across all professions. Fee levels are recommended by the Department, and approved by the Joint Committee on Finance through a 14-day passive review process, to be effective in the subsequent biennium, beginning on July 1, 2015.

Since the change to a passive review-based fee setting process in the 2009-11 biennium, the Department has consistently recommended, and the Committee approved, maintaining most fees at the level set in the 2009-11 biennium, rather than basing fees on the agency's costs of regulating each profession.

Additionally, since its creation, DSPS has lapsed significant program revenue (PR) balances to the general fund each year. The table shows the amounts lapsed to the general fund by DSPS since 2011-12 for the professions formerly regulated by Department of Regulation and Licensing. These lapses reflect that, in aggregate, the current fee revenues exceed costs DSPS incurs to regulate these professionals.

#### 2015-17 Cost Allocation Study Results

At the time that the Department submitted its 2015-17 credential fee proposal to the Committee, the results of the most recent cost allocation study were not included with the request. These results have now been forwarded, and are provided in Attachment 1. The attachment demonstrates that fee levels for most professions do not reflect the cost of regulating each profession, as shown in the "Difference" column.

It is important to note that the estimated cost of regulating each profession includes costs associated with issuing initial and renewal credentials, enforcement activities, and administrative and statutorily required lapse amounts shared among all professions. For professions with fewer individuals, significant costs, particularly as it relates to enforcement activities, could lead to a disproportionately high cost of regulation in the cost allocation study, whereas professions with more initial and renewal applicants have these costs spread out among all credential holders. For example, there are only five credentialed electrology instructors in the state that renewed their credentials between July 1, 2012 and June 30, 2014. Based on the results of the cost allocation study, the renewal fee for this profession would be \$2,367. Conversely, 13,461 certified public accountants sought to renew their credentials during that same time period. Based on the results of the cost allocation study, the renewal fee for this profession would be \$80, which reflects the large number of applicants among whom these regulatory costs are shared.

The following tables show the professions with the highest and lowest number of initial and renewal credential holders, the current initial and renewal fees for those professions, the estimated cost of credentialing and regulating these professions based on the results of the cost allocation study, and the difference between the current fee levels and the results of the cost allocation study. These tables illustrate that professions with higher numbers of credential holders are more likely to have fees that approximate the cost of regulation because there are so many applicants among whom these costs are shared.

### **Description of Fee Proposal**

A complete list of the proposed fee levels is provided in Attachment 2. Under the current fee proposal, DSPS recommends the following changes.

a. Maintaining most initial and renewal credential fees at the levels set in the 2009-11, 2011-13, and 2013-15 biennia. This continues the 2011-13 and 2013-15 policy proposed by DSPS, and approved by the Committee, when nearly all fees were kept at the levels in effect for the 2009-11 and 2011-13 biennia.

b. Setting the new and renewal fees for barber establishments, barbering managers, barbers, barbering instructors, and barbering schools at \$75 and \$82, respectively, and setting the fee for barber apprentices at \$10. (Barbering professions and establishments were previously credentialed under the cosmetology credentials. These professionals and establishments were separated out effective July 1, 2012.)

c. Setting the new and renewal fees for anesthesiologist assistants at \$75 and \$82, respectively (The anesthesiologist assistant credentialing requirements went into effect November 1, 2012).

d. Reducing the listed registration fee for cemetery authorities from \$20 to \$10 to correct an error in the previous fee proposal. The statutes set the fee at \$10, the amount which the Department has been charging. However, the list of fees submitted in the past listed this fee as \$20. The fee proposal corrects this error in the list, although the \$10 amount was in effect prior to this proposal, and could not be changed without legislation.

The Department projects that these fee levels will generate sufficient revenue to cover the anticipated agency costs over the 2015-17 biennium.

The Committee may wish to approve the proposed fee levels, as this would be consistent with past practice (Alternative 1). This option would prevent significant changes to the current fees, but would not result in fees that reflect recent administrative and regulatory costs.

Alternatively, the Committee could deny the request and require the Department to submit a fee schedule that better reflects the recent costs of regulating professions for which the fee study may provide a reliable indicator of costs. In a subsequent submission, the Committee could consider a fee schedule that more closely reflect costs, based on the statutory requirement for DSPS to submit a fee proposal that reflects "the approximate administrative and enforcement costs of the Department that are attributable to the regulation of the particular occupation or business during the period in which the initial or credential renewal is in effect." For example, the Committee could require the Department to propose fee levels based on the results of the cost allocation study for professions with over 2,000 initial or 2,000 renewal applicants (Alternative 2), based on the premise that the cost allocation study may more accurately reflect the costs of regulating these professions.

### ALTERNATIVES

1. Approve the request.

2. Deny the request. Require the Department to submit proposed fee levels that more accurately reflect credentialing and regulatory costs for professions with over 2,000 initial and renewal applicants by May 1, 2015, for the Committee's review and approval under a 14-day passive review process.
