The Department of Workforce Development requests the transfer of \$3,030,900 GPR in fiscal year 2018-19 from its workforce training; programs, grants and services appropriation under s. 20.445(1)(b) to its local youth apprenticeship grants appropriation under s. 20.445(1)(e) to meet the anticipated demand for the Local Youth Apprenticeship Program.
