# 2019 ASSEMBLY BILL 816

- January 28, 2020 Introduced by Representatives Plumer, Subeck, Skowronski, Allen, Anderson, Billings, Bowen, Brostoff, Cabrera, Dittrich, Duchow, Goyke, Hesselbein, Hintz, Katsma, Knodl, Kulp, L. Myers, Ohnstad, Ott, Quinn, Pronschinske, Riemer, Rohrkaste, Sargent, Sinicki, Spreitzer, Stafsholt, Steffen, Stubbs, Tittl, Tusler, Vining, Vorpagel, Vos and Vruwink, cosponsored by Senators Darling, Kooyenga, Carpenter, Jacque, Johnson, Larson, Miller, Ringhand, Risser, Schachtner and Wanggaard. Referred to Committee on State Affairs.
- AN ACT to amend 115.28 (55) (title); and to create 115.28 (56), 118.40 (2r) (b) 2. L., 118.40 (2x) (b) 2. L., 118.60 (2) (a) 9., 119.23 (2) (a) 9. and 121.02 (1) (L) 8. of the statutes; relating to: incorporating the Holocaust and other genocides into the state model social studies standards and requiring instruction on the Holocaust and other genocides.

#### Analysis by the Legislative Reference Bureau

This bill requires the state superintendent of public instruction to incorporate the Holocaust and other genocides into the model academic standards for social studies and to develop model curricula and instructional materials on the same subject. Under the bill, in developing the model curricula and instructional materials, the state superintendent must consult with an organization in this state that provides Holocaust education programs to public and private schools and offers educational tools and training to teachers and with a state agency in another state that has developed model curricula on the Holocaust. Finally, the bill requires a school board, independent charter school, and private school participating in a parental choice program to include instruction on the Holocaust and other genocides in its respective curriculum at least once in grades 5 to 8 and once in grades 9 to 12.

13	on the Holocaust and other genocides at least once in grades 5 to 8 and at least once
14	in grades 9 to 12.
15	SECTION 8. Nonstatutory provisions.
16	(1) MODEL CURRICULA AND INSTRUCTIONAL MATERIALS. In developing the model
17	curricula and related instructional materials required under s. 115.28 $\left(56\right)$ (b) and
18	(c), the state superintendent of public instruction shall consult with all of the
19	following:
20	(a) An organization in this state that is dedicated to Holocaust remembrance,
21	Holocaust education, and the preservation of the memory of victims of the Holocaust
22	and provides free Holocaust education programs to public and private schools and
23	offers educational tools and training to teachers.
24	(b) A state agency in another state that has developed a model curriculum on
25	the Holocaust and other genocide.
