2019 SENATE BILL 478

October 4, 2019 – Introduced by Senators L. TAYLOR, SMITH, HANSEN and WIRCH, cosponsored by Representatives L. MYERS, OHNSTAD, ANDERSON, STEFFEN, SINICKI, EMERSON, POPE, CABRERA, BILLINGS, HAYWOOD and ZAMARRIPA. Referred to Committee on Local Government, Small Business, Tourism and Workforce Development.

AN ACT to amend 173.41 (15) (b) 1. and 173.41 (15) (c); and to create 173.41 (9m) and 173.41 (15) (am) of the statutes; relating to: sales of dogs and cats by pet stores and providing a penalty.

Analysis by the Legislative Reference Bureau

This bill prohibits a pet store from selling dogs and cats beginning on January 1, 2020. A person who violates this prohibition is subject to a civil forfeiture of up to \$10,000 for the first offense and up to \$25,000 for the second or any subsequent offense.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

4	SECTION 1. 173.41 (9m) of the statutes is created to read:
5	173.41 (9m) PET STORES. (a) In this subsection:
6	1. "Breeder" means a person who breeds or raises any number of dogs or cats
7	to call each on mo otherwise there for to a nerver other there a breader or dealer

2. "Dealer" means a person who, for compensation, buys, sells, or negotiates the
 purchase of a dog, or delivers for transport or transports a dog. "Dealer" does not
 include a person who transports a dog only as a carrier.

3. "Pet store" means a for-profit establishment that is open to the public and
that sells or offers for sale domestic animals to be kept as household pets. "Pet store"
does not include an animal control facility or animal shelter that holds a valid license
under sub. (2); or a humane society, animal welfare society, animal rescue group, or
other nonprofit group whose mission and practice is the rescue of animals and the
placement of those animals in permanent homes and that does not obtain animals
from a breeder or dealer in exchange for compensation.

(b) No person may sell, offer for sale, or transfer a dog or cat from a pet store.
(c) Notwithstanding par. (b), nothing in this subsection shall be construed as prohibiting a pet store from allowing an animal control facility, animal shelter, humane society, animal welfare society, animal rescue group, or other nonprofit group from showcasing, in the pet store, animals that are available for adoption.

SECTION 2. 173.41 (15) (am) of the statutes is created to read:

17 173.41 (15) (am) A person who violates sub. (9m) or a rule promulgated under 18 this section relating to sub. (9m) may be required to forfeit not more than than 19 \$10,000 for the first offense and may be required to forfeit not more than \$25,000 for 20 the 2nd or any subsequent offense. If a violation under this paragraph involves the 21 sale, offer for sale, or transfer of a dog or cat in violation of sub. (9m) (b), each sale, 22 offer for sale, or transfer of a dog or cat constitutes a separate violation.

23 **SECTION 3.** 173.41 (15) (b) 1. of the statutes is amended to read:

24 173.41 (15) (b) 1. Except as provided under par. pars. (a) and (am), a person who
25 violates this section or a rule promulgated under this section may be required to

forfeit not more than \$1,000 for the first offense and may be required to forfeit not
 less than \$200 nor more than \$2,000 for the 2nd or any subsequent offense within
 5 years.

4 **SECTION 4.** 173.41 (15) (c) of the statutes is amended to read:

5 173.41 (15) (c) In addition to the penalties under pars. (a), (am), and (b), a court

6 may order a person who violates this section to pay the expenses of caring for dogs

7 that are removed from the person's possession because of mistreatment.
