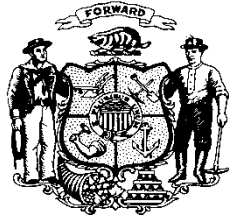

II. Department of Corrections – Jared Hoy, Secretary-Designee

The Department of Corrections requests a one-time supplement of \$4,000,000 GPR in fiscal year 2024-25 from the committee's appropriation under s. 20.865(4)(a) to the department's services for community corrections appropriation under s. 20.410(1)(b) for the implementation of community reentry centers.

III. Department of Natural Resources – Steven Little, Deputy Secretary

The Department of Natural Resources requests the transfer of \$80,000 SEG in fiscal year 2024-25 from the department's recreation aids – all-terrain vehicle and utility terrain vehicle project aids appropriation under s. 20.370(5)(cu) to the department's law enforcement – all-terrain vehicle and utility terrain vehicle enforcement communications technology appropriation under s. 20.370(3)(au) to provide grants to nonprofit

organizations supporting all-terrain and utility terrain vehicle recreation for the acquisition and maintenance of communications equipment and digital information.
