1. Basis and purpose of the proposed rule.

The proposed rules consist of revisions in chapter Comm 5 in order to address some administrative issues that have occurred since the last update of chapter Comm 5. Chapter Comm 5 establishes qualifications and procedures for licensing, certifying and registering various individuals and entities associated with the construction of buildings. The proposed revisions are to reflect recent statutory changes, to clarify the application or intent of certain rules, and to provide consistency across certain related credential types. Most of the credentials under chapter Comm 5 have been established under the statutory authority and mandates of chapters 101 and 145, Stats.

2. How the proposed rule advances relevant statutory goals or purposes.

The proposed changes reflect the intent of the credential rules under chapter Comm 5 to facilitate or promote public health, safety and welfare in the construction or use of buildings.
