**I. THE PROPOSED RULE:**

The proposed rule, including the analysis and text, is attached.

**II. REFERENCE TO APPLICABLE FORMS:**

No new or revised forms are required by these rules.

**III. FISCAL ESTIMATES:**

The department estimates that this rule will require staff time in the Division of Professional Credentialing and the Division of Board Services. The total staff salary and fringe is estimated at \$2,100. The department also finds that this rule has no significant fiscal effect on the private sector.

**IV. STATEMENT EXPLAINING NEED:**

The proposed revision changes the current rules to recognize and incorporate developments in the land surveyor profession, including new experience options in the field of surveying; modifies the experience requirement to include the preparation of transportation project plats and condominium plats; and clarifies the type of other experience that would be allowed to satisfy the requirements for licensure. The proposed revisions also reflect changes in the land surveying curriculum as a result of advances in surveying technology, and specifically recognizes that such courses satisfy the educational requirements for registration as a land surveyor in Wisconsin.
