2006 migratory game bird seasons and waterfowl hunting zones

Board Order No. WM-26-06  
Clearinghouse Rule No. 06-074

#### Basis and Purpose of the Proposed Rule

Under international treaty and federal law, migratory game bird seasons are closed unless opened annually via the U.S. Fish and Wildlife Service (USFWS) regulatory process. Migratory birds are managed in one of 4 flyways that encompass North America. Each flyway has a Flyway Council consisting of one member from each state and province in that flyway. Wisconsin is part of the Mississippi Flyway and is one of 17 members on the Mississippi Flyway Council (MFC). The USFWS annually prescribes the outside limits (frameworks) within which states may select hunting season parameters. This process involves the USFWS working cooperatively with each Flyway Council.

#### Summary of Public Comments

Due to the Federal schedule for establishing waterfowl hunting regulations, the process for receiving public input on proposed state waterfowl seasons is very condensed, however, most active waterfowl groups and individuals are aware of the time frame. On July 28, the US Fish and Wildlife Service announced the season framework that the states could use to develop their state waterfowl hunting season. During a period of 19 days, the Department developed a season proposal, issued press releases and website information, conducted 2 advisory committee meetings, held an open public meeting with waterfowl hunters, received input via email, mail and telephone and conducted 4 public hearings around the state. The results of this public input were presented to the Natural Resources Board on August 16 where 3 citizens testified on the proposed rule. The attendance at the advisory committee meetings and open public meeting was approximately 70 people total, 83 comments were received from email/mail/telephone and 69 people attended the 4 public hearings. The majority of the public comments received through this process were in support of the season as proposed. The season opening dates, southern duck zone season splits and opening days shooting hours had the most varied public input.

The Department proposed the northern duck zone to open on September 23 with no season split and 33 individuals, 5 waterfowl groups supported this date; 3 individuals wanted this zone to open on Sept 23 but with a split; and 33 individuals, 2 waterfowl groups and the Conservation Congress Migratory Committee wanted this zone to open on September 30 or later. This was the first year that several northwest Wisconsin counties were in the northern zone and the hunters there have been asking for the zone line change for years in order to open earlier. The Natural Resources Board decided to keep the opening date for the northern duck zone at September 23.

The Department proposed that the southern duck hunting zone open on September 30 and close (split) for 5 days (Monday – Friday) in October in order to extend the season later into December. The Conservation Congress Migratory Committee, 7 waterfowl groups and 77 individual comments favored opening on September 30, 2 groups and 3 individual comments favored opening on September 23 and 19 individual comments supported opening October 7 or later. Four waterfowl groups and 23 individual comments favored the proposed 5 day split; the Conservation Congress Migratory Committee, 3 groups and 18 individual comments favored a 9 day split; 23 individuals requested a split longer than 5 days while 2 groups and 1 individual comment requested no split in the season. The Department

recommended and the NRB accepted a change to a 7 day season split from the original proposal of 5 days.

Based on public input during 2005, the Natural Resources Board asked the Department to recommend a change in the opening day shooting hours from noon to a midmorning time in 2006. The Department proposed a 9 am opening time for shooting hours on opening day of the duck season. The Conservation Congress, 1 waterfowl group and 37 individual comments supported this proposal; 5 groups and 7 individual comments favored keeping the noon opener while 2 waterfowl groups and 20 individual comments favored opening shooting hours ½ hour before sunrise.
