REPORT ON Section Ins 9.25 (8) and 9.27 (4), Wis. Adm. Code, relating to preferred provider plan applicability dates and affecting small business

Clearinghouse Rule No 06-118

(a) A detailed statement of basis for the proposed rule and how the rule advances relevant statutory goals or purposes:

The proposed rule clarifies the applicability dates for ss. Ins 9.25 and 9.27, Wis. Adm. Code, and specifies that insurers offering preferred provider plans that are issued prior to January 1, 2007 and periodically renewed after December 31, 2006 and that would otherwise be affected by ss. Ins 9.25 and 9.27, Wis. Adm. Code, will be grandfathered from compliance with the new requirements. The requirements of ss. Ins 9.25 and 9.27, Wis. Adm. Code, will be applicable to an insurer offering a preferred provider plan on or after January 1, 2007.

(f) The response to the Legislative Council staff recommendations indicating acceptance of the recommendations and a specific reason for rejecting any recommendation:

All comments were complied with and corrected except the following:

Comment Section 1 requests no modifications but rather a response as to whether the Legislative Council's interpretation is accurate. In response the Office notes that the language in question was specifically provided to the Office by the Joint Committee for Review of Administrative Rules. The Office disagrees with Legislative Council's comment that only a court can make a determination of statutory interpretation regarding Wis. Stat. § 609.35, as this agency is charged with interpreting and implementing Wis. Stats. § 600-655 pursuant to Wis. Stat. § 601.41 (1).

(g) The response to the report prepared by the small business regulatory review board:

The small business regulatory review board did not prepare a report.

(h) Final Regulatory Flexibility Analysis
