Subject: Announcement of Public Hearing

I have attached the required material for the announcement of a public hearing on the proposed rules to update the technical requirements for the installation of electrical wiring and equipment. We are submitting this package to you for your review and approval of the proposed rules. Because the cut off for submission to the legislature is September 1, 2008, we have tentatively set the public hearing for June 18, 2008. Therefore, the secretary's approval will be needed by May 14 to facilitate publication in the end of May Administrative Register.

The proposed rules consist of an update of chapter Comm 16, Electrical Code, including the incorporation by reference of the 2008 edition of the National Electrical Code (NEC) published by the National Fire Protection Association. The update of chapter Comm 16 involves the proposed adoption of the 2008 NEC that requires the installation of tamper-resistant receptacles and arcfault circuit-interrupter protection in all new dwelling construction. The estimated increase to install tamper-resistant receptacles and arc-fault circuit-interrupters in an average dwelling would be \$215. Also, several current rules that are covered in the 2008 NEC were deleted and other rules were added where the NEC needs clarification or reinforcement. The proposed rules were developed with the assistance of a 13-member advisory council, and the rule draft reflects the recommendations of the council.

Please review the attached material and let me know if you have any questions. If we can proceed with announcing the public hearing, please sign the required forms and letters and return this package to Joe Hertel. We will then schedule the hearing, and prepare and distribute the required packages.
