Assumptions Used in Arriving at Fiscal Estimate

The objective of the rule is to create ch. DFI—CU 65. The purpose of the rule is to set forth certain procedures and requirements for credit union service organizations, including notice, corporate separateness, legal opinions, expansion of services, conflicts of interest, report and audit procedures, increase of investment, and supervision. The rule's requirements place no additional duties or burdens on state or local government, and hence has no effect on costs to either.
