### DEPARTMENT OF HEALTH SERVICES REPORT TO THE LEGISLATURE

#### CLEARINGHOUSE RULE 13-028

Ch. DHS 132, Nursing Homes

#### **Basis and Purpose of Proposed Rule**

Section 50.04 (8), Stats., created by 2011 Wisconsin Act 70, explicitly authorizes the department to: 1) distribute moneys from the appropriation account under s. 20.435 (6) (g), Stats., for innovative projects designed to protect the property and the health, safety, and welfare of residents in nursing homes and to improve the efficiency and cost effectiveness of the operation of facilities so as to improve the quality of life, care, and treatment of residents; 2) establish and maintain a quality assurance and improvement committee (committee) to review proposals and award moneys for innovative projects that are approved by the committee; and 3) promulgate rules to guide the actions of the committee.

In reviewing the requirements of s. 50.04 (8), Stats., the department determined that s. DHS 132.16 meets the intent and purpose of s. 50.04 (8), Stats. The department interpreting, s. 49.499, Stats., under the authority provided in ss. 50.02 (2) (a) and s. 227.11 (2), Stats. (2007-2008), created s. DHS 132.16 effective September 1, 2007, to direct the establishment of a quality assurance and improvement committee and to guide the actions of the committee, including when reviewing proposals and awarding moneys for innovative projects.

Because the department believes that s. DHS 132.16 (1) and the committee established thereunder meet the purpose of s. 50.04 (8), Stats., as created by 2011 Wisconsin Act 70. The department proposes only to amend s. DHS 132.16 (1) to insert a cross-reference to s. 50.04 (8) Stats., as indication of the department's now explicit authority to establish and maintain a committee to review proposals and award moneys for projects, and to promulgate rules to guide the actions of the committee.

#### **Department Response to Legislative Council Rules Clearinghouse Recommendations**

The department accepts the recommendation(s) made by the Legislative Council Rules Clearinghouse and has modified the proposed rules where suggested except as follows.

Clearinghouse Comment 2. a.: Section 227.14 (2) (a) 3., Stats., requires, in the analysis that accompanies the proposed rule, a summary of and preliminary comparison with any existing or proposed federal regulation that is intended to address the activities to be regulated by the proposed rule. Section 227.14 (2) (a) 4., Stats., requires a comparison with similar rules in Illinois, Iowa, Michigan, and Minnesota. The proposed rule's analysis does not contain a statement of whether or not similar federal or state rules exist, and, if they do exist, a summary of the rules and comparison with the proposed rule.

Department Response: No change was made. The rules required under s. 50.04 (8) (b)., Stats., already exist in s. DHS 132.16 (1). During promulgation of the rules in 2007, the department analyzed federal and adjacent state regulations pursuant to s. 227.14 (2) (a) 3. and 4. Stats. The department's current proposal is only to insert a cross-reference into existing rules to identify its now explicit authority for rules on the creation and guidance of a quality assurance committee.

### **Final Regulatory Flexibility Analysis**

The department did not hold a public hearing nor did the department formally accept public comments on the proposed rule as permitted under s. 227.16 (2) (b), Stats.

As permitted under s. 227.16 (2) (b), Stats., the department did not hold a public hearing nor did the department formally accept public comments on the proposed rule.
