Clearinghouse Rule 14-058  
Wis. Admin. Code VA 2.07

The Department of Veterans Affairs proposes an order to amend VA 2.07, relating to grants to non-profit organizations.

**a) Proposed rule:**

**b) Rule summary:**

This rule establishes the general criteria, procedures, requirements and conditions for the award of grants to nonprofit organizations that provide assistance to veterans and their families. It allows for grant applications from any nonprofit, as defined in s.108.02 (19) Stats., to provide financial assistance or other services to veterans and their dependents. The applications are evaluated based upon 11 enumerated factors relating to both the specific merits of the plan and the experience of the applicant organization. Applicants are evaluated based upon different selection criteria, which will be assigned pre-determined point values by an evaluation committee comprised of members of the Board of Veterans Affairs. The Department shall award grants to the applicants with the highest numerical score based upon the total scores of the combined points. Each applicant will be notified in writing of the Department's decision.

The rule provides for solicitation of applications for grants in the form of public notice. Each grant applicant will be asked to provide: (1) proof of nonprofit status; (2) information about itself; (3) description of the financial assistance or other services it provides to veterans and their dependents; and (4) description of the need for the requested funds.

**k) A detailed statement explaining the basis and purpose of the proposed rule, including how the proposed rule advances relevant statutory goals or purpose:**

Act 190 creates s. 45.46, Stats., which provides the Department of Veterans Affairs authority to award grants to non-profit organizations that provide assistance to veterans or their families.

Section 45.03 (1), Stats., authorizes the Secretary of the Department of Veterans Affairs to promulgate rules necessary to carry out the purposes of Chapter 45 and the powers and duties conferred upon it.

Section 227.10 (1), Stats., directs each agency to promulgate as a rule each statement of policy to govern its enforcement and interpretation of a statute and section 227.10 (2m), Stats., directs each agency to promulgate rules for the implementation or enforcement of any standard, requirement, or threshold.

The Department has existing rules related to grants awarded to veterans service organizations and counties for the delivery of services to veterans, and also specifically for transportation services provided to veterans. The existing rules, however, are insufficient and inappropriate for the new grant authority.

The proposed new policies will create a process for non-profit organizations that provide financial assistance or other services to veterans and their dependents to apply for grant funds not to exceed \$25,000 per fiscal year. The proposed rule will require a non-profit organization to submit: (1) proof of non-profit status; (2) information about itself; (3) a description of the financial assistance or other services it provides to veterans and their dependents; (4) and describe their need for the requested

funds. The proposed rule will require the Board of Veterans Affairs to review the applications for these grants and make recommendations of award to the Secretary of the Department.
