I am petitioning for authorization to repeal portions of the administrative code relating to the storage, use, and handling of flammable or combustible liquids and products as referenced in ch SPS 305. A copy of the proposed rule is attached.

2013 Wisconsin Act 20, section 9138 (3) (fm) and (f), transferred authority relating to the storage, use, and handling of flammable or combustible liquids, and the storage and inspection of petroleum products under ss. 101.09 and 101.142, 2011 stats., and chapter 168, 2011 stats., to the Department of Agriculture, Trade and Consumer Protection. The Department of Agriculture, Trade and Consumer Protection has submitted Rules Clearinghouse No. 17-092, *Proposed Order of the Wisconsin Department of Agriculture, Trade and Consumer Protection* to repeal and recreate ch ATCP 93, relating to flammable, combustible, and hazardous liquids in Wisconsin. The administrative rules in SPS 305 relating to the storage, use, and handling of flammable or combustible liquids and products are no longer relevant in light of the proposed ch. ATCP 93 in Rules Clearinghouse No. 17-092.

Therefore, the Department is requesting authorization to repeal the rule by utilizing the expedited process under s. 227.26 (4), Stats.

ANALYSIS

Statutes interpreted:

2013 Wisconsin Act 20, sections 9138 (3) (fm) and (4) (f)

Statutory authority:

Explanation of agency authority:

2013 Wisconsin Act 20, section 9138 (3) (fm), states that, "all rules promulgated ... by the department of safety and professional services, that ... relate to the storage, use, and handling of flammable or combustible liquids or federally regulated hazardous substances under section 101.09, 2011 stats., and that are in effect on the effective date of this paragraph shall remain in effect until their specified expiration date or until amended or repealed by the department of agriculture, trade and consumer protection."

2013 Wisconsin Act 20, section 9138 (4) (f), states that, "all rules promulgated ... by the department of safety and professional services, that ... relate to the storage and inspection of petroleum products under section 101.142, 2011 stats., and chapter 168, 2011 stats., and that are in effect on the effective date of this paragraph shall remain in effect until their specified

expiration date or until amended or repealed by the department of agriculture, trade and consumer protection."

Section 168.16 (4), Stats., states that "the department may promulgate reasonable rules relating to the administration and enforcement of this chapter."

Section 227.11 (2) (a), Stats., sets forth the parameters of an agency's rule-making authority, stating an agency, "may promulgate rules interpreting provisions of any statute enforced or administered by the agency. . .but a rule is not valid if the rule exceeds the bounds of correct interpretation."

Related statute or rule:

Rules Clearinghouse No. 17-092, *Proposed Order of the Wisconsin Department of Agriculture, Trade and Consumer Protection* to repeal and recreate ch ATCP 93, relating to flammable, combustible, and hazardous liquids in Wisconsin.

ATCP chapters 93 (renumbered from SPS 310 and SPS 302.43) and 94 (renumbered from SPS 348), *Administrative Register*, October 2013 No. 694

Plain language analysis:

Section 1 repeals a note directing users to DATCP for applications and forms related to petroleum hazardous storage tanks.

Section 2 repeals the fee schedule related to credentialing authority that is no longer vested with DSPS and now is with DATCP.

Section 3 repeals the term schedule related to credentialing authority that is no longer vested with DSPS and now is with DATCP.

Section 4 repeals the sections of chapter 305, subchs. VI and VIII, and corresponding Notes which define the credentialing requirements for Storage Tank credential holders that are no longer vested with DSPS and now is with DATCP.
