The Wisconsin Controlled Substances Board took affirmative action on October 9, 2018 to similarly treat Food and Drug Administration approved drug products that contain cannabidiol as schedule V controlled substance effective October 15, 2018. The Board is currently promulgating a final rule.</p>
