Report From Agency

Ch. DHS 109, relating to SeniorCare prescription drugs

Basis and Purpose of Proposed Rule

In 2019 Wisconsin Act 185, the Wisconsin Legislature expanded the definition of a "prescription drug" covered under the SeniorCare program to include designated vaccinations. Current rules exclude vaccinations from the prescription drug definition. Expansion of rules to provide for adequate regulation of SeniorCare covered vaccination is needed, including coverage scope, reimbursement and deductible guideline establishment and record maintenance.

Department Response to Legislative Council Rules Clearinghouse Recommendations

The department accepted the recommendations made by the Legislative Council Rules Clearinghouse and has modified the purposed rules where suggested.

The department solicited the input of SeniorCare providers, including small businesses, as required by state and federal law. Additionally, the department solicited comments on the economic impact of the proposed rule changes from all parties interested in providing comments by publishing a solicitation for public comment in the Administrative Register and on the department's website. The proposed rules are not anticipated to have an economic or fiscal impact.
