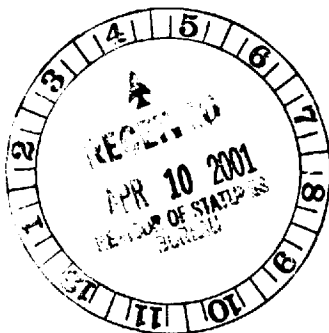

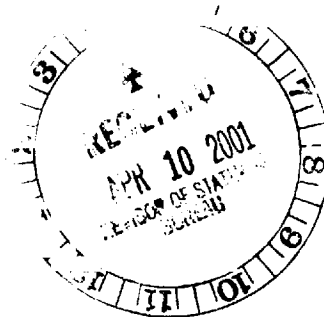

AN ORDER of the State of Wisconsin Pharmacy Internship Board to repeal Ph-Int 1.02(1) and 1.07(5); to renumber Ph-Int 1.02(2), 1.02(5), 1.02(6), 1.02(9), 1.02(10), 1.02(12), and 1.07(7); to renumber and amend Ph-Int 1.02(3), 1.02(4), 1.02(7), 1.02(8), 1.02(11), and 1.07(6); to amend Ph-Int 1.03(1), 1.03(2)(intro), 1.03(2)(g), 1.05, 1.06(2), 1.06(3), 1.06(4)(a), 1.06(4)(c), 1.06(4)(e), 1.07(1)(a), and 1.07(2); to repeal and recreate Ph-Int 1.04(1), 1.04(4), and 1.06(4)(d); and to create Ph-Int 1.01(3), relating to pharmacy intern training.

Analysis Prepared by the State of Wisconsin Pharmacy Internship Board

The rule changes propose to expand the definition of pharmacy intern to include graduates of non-US pharmacy schools, to expand the scope of potential pharmacy internship learning sites to include certain approved sites which are not licensed pharmacies, to modify the requirements for pharmacy internship credit to reflect the elimination of the bachelor's degree program in pharmacy, to increase the amount of internship credit which may be granted for less than full-time internship training, to reduce the amount of practice experience required of a preceptor, to eliminate the requirement that a pharmacy have been licensed and in existence for at least 12 months in order to qualify as a pharmacy learning site, to grant the pharmacy internship board increased discretion to grant exceptions to internship and preceptor requirements, and various administrative and clerical modifications.

Pursuant to authority vested in the State of Wisconsin pharmacy internship board by s. 36.25(20), Stats., the state of Wisconsin pharmacy internship board proposes to amend, repeal, and create rules interpreting ss. 36.25(20) and 450.045, Stats., as follows:

Section 1. Ph-Int 1.01 (3) is created to read:

Ph-Int 1.01 (3) Definitions.

(a) In this chapter, "pharmacy" means a facility licensed under s. 450.06.

(b) In this chapter, "pharmacy internship learning site" means a site for pharmacy internships, other than a licensed pharmacy, which is approved by the pharmacy internship board as a location for pharmacy internships.

(c) In this chapter, "pharmacy intern" means all persons participating in internship for credit or a non-credit internship.

(d) In this chapter, "internship-for-credit" means: 1. those periods of internship training which meet the requirements of the internship program; 2. internship practice activities on a part-time basis as part of an academic professional experience program sponsored by a professional Bachelor of Science degree in pharmacy or a Doctor of Pharmacy degree granting institution; and 3. internship practice activities conducted by persons who have successfully graduated from a school or college of pharmacy outside the United States and who meet the prerequisites for pharmacy internship as determined by the pharmacy internship board.

(e) In this chapter, "non-credit internship" means: 1. those periods of internship subsequent to licensure as a pharmacist in another state and prior to licensure in Wisconsin; 2. those periods of internship subsequent to the completion of 1500 hours of internship-for-credit and prior to licensure in Wisconsin; 3. those periods of internship when an applicant is enrolled in an accredited school or college of pharmacy; and 4. such other periods of internship as may be allowed upon written request of the pharmacy internship board.

Section 2. Ph-Int 1.02(1) is repealed in its entirety.

Section 3. Ph-Int 1.02 (2) is renumbered Ph-Int 1.02 (1).

Section 4. Ph-Int 1.02 (3) and (4) are renumbered Ph-Int 102 (2) and (3) and amended to read:

Ph-Int 1.02 (2) Internship registration may be granted to any ~~one~~ person who has successfully completed the fourth year of an accredited school or college of pharmacy curriculum.

Ph-Int 1.02 (3) Initial internship registration for credit must be for a period of not less than 60 days, or for shorter periods as may be allowed at the written request of the pharmacy internship board.

Section 5. Ph-Int 1.02(5) and 1.02(6) are renumbered Ph-Int 1.02(4) and 1.02(5).

Section 6. Ph-Int 1.02 (7) and (8) are renumbered Ph-Int (6) and (7) and amended to read:

Ph-Int 1.02 (6) Registration as an intern expires on May 31 in the third year succeeding the year in which the registration fee was recorded, unless revoked, suspended or canceled.

Ph-Int 1.02 (7) Registration as an intern is valid for internship training only in the pharmacy or pharmacy internship learning site listed on the internship application, except that a period of internship training not to exceed 30 days may be allowed at a different pharmacy or pharmacy internship learning site. Periods of internship training greater than 30 days at a different pharmacy or pharmacy internship learning site may be allowed upon written request of the pharmacy internship board.

Section 7. Ph-Int 1.02 (9) and (10) are renumbered Ph-Int (8) and (9).

Section 8. Ph-Int 1.02 (11) is renumbered Ph-Int 1.02 (10) and amended to read:
Application for pharmacy internship training shall be received by the pharmacy internship board at least 14 days prior to the beginning of internship training.

Section 9. Ph-Int 1.02 (12) is renumbered Ph-Int 1.02 (11).

Section 10. Ph-Int 1.03(1), (2)(intro) and 2(g) are amended to read:

Ph-Int 1.03 Time of internship. (1) PRACTICE AND EXPERIENCE. Candidates for licensure as a pharmacist shall have on file with the pharmacy internship board proof of having satisfactorily completed an aggregate of at least 1500 hours of internship-for-credit under the personal supervision of a registered pharmacist who is certified as a preceptor by the pharmacy internship board, or of having completed an out-of-state pharmacy internship which meets the pharmacy internship board requirements of the state of Wisconsin.

Ph-Int 1.03 (2) INTERNSHIP-FOR-CREDIT. In granting or denying credit the director of pharmacy internship shall consider whether the applicant's entire 1500 hours of internship present a balanced practice and experience of the responsibilities of a licensed pharmacist. Credit shall be allowed in accord with the following conditions:

Ph-Int 1.03 (2)(g) No more than 320 hours of internship credit, in aggregate, shall be granted for less than full-time internship training concurrent with academic registration in a Doctor of Pharmacy degree program.

Section 11. Ph-Int 1.04(1) and (4) are repealed and recreated to read:

Ph-Int 1.04(1) The preceptor may supervise an intern pursuant to Phar 7.01(3).

Ph-Int 1.04 (4) Non-credit internship practice activities as defined in Ph-Int 1.01 (3) (e) (1) (2) (4) may be under the supervision of any pharmacist who is licensed and in good standing.

Section 12. Ph-Int 1.05 is amended to read:

Ph-Int 1.05 Out-of-state internship. Credit for pharmacy internship experience gained in a state other than Wisconsin may be granted by the director of pharmacy internship toward the Wisconsin requirement if the preceptor, practice environment, time considerations and all other aspects of the internship meet the same criteria required of in-state internships. All out-of-state pharmacy internships shall be evaluated by the director of pharmacy internship with the advice of the pharmacy internship board.

Section 13. Ph-Int 1.06 (2) and 1.06(3) are amended to read:

Ph-Int 1.06 (2) Certification must be renewed biennially in conjunction with the state's pharmacist licensure cycle as set forth in s. 440.08(2)(a).

Ph-Int 1.06 (3) A ~~valid~~ certificate attesting to the certification of a preceptor shall be issued by the pharmacy internship board and displayed at the preceptor's pharmacy or pharmacy internship learning site.

Section 14. Ph-Int 1.06 (4)(a) and (c) are amended to read:

Ph-Int 1.06 (4)(a) Completion of 24 months of practice as a registered pharmacist or completion of a post-graduate pharmacy residency or pharmacy fellowship and 12 months of practice as a registered pharmacist.

Ph-Int 1.06 (4)(c) Current practice as a registered pharmacist averaging 32 or more hours weekly, or fewer hours as may be allowed upon written request of the pharmacy internship board.

Section 15. Ph-Int 1.06 (4)(d) is repealed and recreated to read:

Ph-Int 1.06 (4)(d) Meeting the continuing education requirements for pharmacist licensure set forth in s. 450.085 and any such requirements for preceptor certification established by the pharmacy internship board.

Section 16. Ph-Int 1.06 (5) is amended to read:

Ph-Int 1.06 (5) Certification as a preceptor is for a specific location of practice. ~~pursuant to 1.06 (4) (b), a~~ A preceptor shall notify the pharmacy internship board of a change in place of practice within 30 days.

Section 17. Ph-Int 1.06 (4)(e) is amended to read:

Ph-Int 1.06 (4)(e) Participation in preceptor training sessions as established by the pharmacy internship board. Credit for participation may be granted toward the preceptor continuing education requirement established pursuant to par. (d).

Section 18. Ph-Int 1.07 (1)(a) and (2) are amended to read:

Ph-Int 1.07 (1) SCOPE. (a) The pharmacy or pharmacy internship learning site in which internship training takes place must exemplify comprehensive pharmaceutical practice.

Ph-Int 1.07 (2) PATIENT AND INTER-PROFESSIONAL RELATIONS. The pharmacy or pharmacy internship learning site practice must provide an environment in which pharmacist-patient and pharmacist-physician interactions and consultations occur at sufficient frequency to provide a generally acceptable level of expertise in this phase of practice.

Section 19. Ph-Int 1.07 (5) is repealed in its entirety.

Section 20. Ph-Int 1.07 (6) is renumbered 1.07 (5) and amended to read:

Ph-Int 1.07 (5) ETHICS. The policies and practices of pharmacists in the pharmacy or pharmacy internship learning site should conform to the legal and ethical standards of professional practice.



(d) In this chapter, *Ainternship-for-credit@* means: 1. those periods of internship training which meet the requirements of the internship program; 2. internship practice activities on a part-time basis as part of an academic professional experience program sponsored by a professional Bachelor of Science degree in pharmacy or a Doctor of Pharmacy degree granting institution; and

(e) In this chapter, Anon-credit internship@ means: 1. those periods of internship subsequent to licensure as a pharmacist in another state and prior to licensure in Wisconsin; 2. those periods of internship subsequent to the completion of 1500 hours of internship-for-credit and prior to licensure in Wisconsin; 3. those periods of internship when an applicant is enrolled in an accredited school or college of pharmacy; and 4. such other periods of internship as may be allowed upon written request of the pharmacy internship board.

Periods of internship training greater than 30 days at a different pharmacy or pharmacy internship learning site may be allowed upon written request of the pharmacy internship board.


