**Initial Regulatory Flexibility Analysis**: UCR may have a small effect on a small number of Wisconsin based interstate trucking companies. For companies up to 1,000 trucks, the maximum underpayment would be up to \$76.00 per year, per truck. For companies with more than 1,000 trucks, the fee per vehicle maxes out at flat fee for \$73,346 for 1,001 or more vehicles. The average maximum underpayment of the fee itself would decline arithmetically from \$73.346 per vehicle as the number of a company's vehicles exceeds 1,000.
