Rules Relating to Grain Dealers, Grain Warehouse Keepers, and Milk Contactors

The Wisconsin Department of Agriculture, Trade and Consumer Protection (“Department”) will convene a public hearing on an emergency rule for milk contactors (ATCP 100) and on a proposed permanent rule for grain dealers, grain warehouse keepers, and milk contactors (ATCP 99 & 100).
