# CHAPTER PI 49 SPECIAL NEEDS SCHOLARSHIP PROGRAM

**NOTICE IS HEREBY GIVEN** that pursuant to s. 115.7915 (10), Stats., and interpreting s. 115.7915, the Department of Public Instruction will hold a public hearing as required under s. 227.16, Stats., to consider the promulgation of Clearinghouse Rule 19-095 and Emergency Rule 1911, amending PI 49 relating to changes to rules governing the special needs scholarship program as a result of 2017 Wisconsin Acts 36 and 59 and other changes. The hearing will be held as follows:

This proposed rule amends ch. PI 49 of the Wisconsin Administrative Code in order to conform Department rules governing the special needs scholarship program to changes in statute as a result of 2017 Wisconsin Acts 36 and 59 and other changes. This proposed rule also includes items that will assist schools, auditors and the department in the administration and implementation of the program since the original rule was promulgated.
