WisDOT has notified 60 agencies of their share of the nearly \$6.3 million in grants to support local transportation options for those with disabilities, including funds for 68 replacement or new vehicles.

WisDOT administers the specialized transportation program for the rural and smaller urban areas of the state and coordinates with larger cities to ensure continuity of the application and project selection process.
