Background

Wis. Stats. § 98.06, sets forth general requirements on how commodities may be sold by weight, measure, or count. Wis. Admin. Code §ATCP 91.03(2), amended in 2009, sets general rules for "ready-to-eat foods". Since current law does not clearly define "single serving", inspectors need to exercise their judgment when dealing with this issue.
