### What does the Driver Eligibility Unit Do?

The Driver Eligibility Unit (DEU) works on:

- Legal Presence
- Fraud/Security Notations
- Out of state issuance
- Undeliverable license/ID card products
- Cancellations involving GDL and sponsorship

## **GDL Restrictions**

### What is GDL?

- Since 2000, Wisconsin has used GDL or Graduated Driver License help novice drivers ages 15 <sup>1</sup>/<sub>2</sub> to 18 to gain knowledge and driving experience while under the supervision of an experienced driver
- GDL restrictions effect both Instruction Permits and Probationary driver licenses
- GDL restrictions on a Probationary License last for 9 months or longer on a license.
- GDL Restrictions no longer are in effect once a driver turns 18

# **GDL Restrictions**

#### **GDL Cancels**

- Teen drivers need to be violation free for 6 months prior to obtaining a probationary driver license
- If a under age 18 driver is convicted of a violation after obtaining a Probationary Driver License but the violation occurred in the 6 months prior to being issued a Probationary Driver License, the driver license is cancelled

#### DRIVER LICENSE APPLICANT UNDER AGE 18 ONLY

**Applicant Certification:** I certify that in the past six months I have not been ticketed for a moving violation that has or may result in a conviction. I understand that falsifying this statement will result in the cancellation of my probationary license. Applicant Signature – **REQUIRED**.

## Sponsorship

### What is Sponsorship?

- Under Wisconsin law, under age 18 drivers require an adult sponsor unless they have SR-22 in lieu of sponsorship.
- Sponsors do the following:
  - accepts liability for any and all driving actions of the minor
  - verify the minor has at least 30 hours of driving experience
  - confirms that the minor is enrolled in school or high school equivalency program
  - confirms the minor is not a habitual truant

# Sponsorship

### Who can be a sponsor?

- Parent (natural or adoptive parent), step-parent, or legal guardian (person named by the court having the duty and authority of guardianship)
- Sponsoring family parent of a foreign student
- If the teen is not living with a parent or court-appointed legal guardian, other approved adults are:
  - Grandparent
  - Aunt or Uncle
  - Sibling 18 years or older
  - Spouse 18 years or older
  - Foster Parent

## Sponsorship

#### **Sponsorship Cancels**

- Withdrawal of Sponsorship When a sponsor of a minor withdrawals/cancels their sponsorship of a minor
- Sponsor Deceased When the sponsor of a minor is reported as deceased to the DMV. DEU notifies the minor that a new sponsor is required to maintain the license

## **REAL ID** What Is REAL ID?

Beginning October 1, 2020, you will need REAL ID compliant identification or other acceptable documentation to fly within the US, visit a military base or other federal buildings.

- Proof of Legal Presence in the US
- Proof of Identity
- Proof of Name Change (if applicable)
- Proof of Social Security Number
- Proof of Address

- If you are under the age of 18, adult sponsorship will be required. You will be asked to provide your adult sponsor information, including their driver license or ID card number, during this transaction.
- · You will be required to enter your email address within this application.
- A valid credit or debit card (Visa, MasterCard, Discover or American Express)
  - For credit or debit card payments, your account will be charged the required duplicate or renewal
    product fee and convenience fee.

#### You will not be able to use this online system if:

- Your Regular (non-Probationary) driver license is expired or will expire within 30 days. Please visit a DMV customer service center to renew.
- Your driver license has been expired for more than two years.
- · Your driver license is suspended, revoked or canceled in Wisconsin or any other state.
- · You are under the age of 18 and have not completed an approved driver education course.
- · Your Federal Medical Card (Fed Med) is expired or your commercial driver license (CDL) is surrendered for
