The Wisconsin Department of Transportation (WisDOT) ensures compliance with a variety of civil rights laws and executive orders which prohibit discrimination on the basis of race, color, national origin, religion, sex, disability and age in programs and activities receiving federal financial assistance. Title VI is a federal statute and provides that no person in the United States, on the grounds of race, color, or national origin, be excluded from participation in, be denied the benefits of, or be subjected to discrimination under any program or activity receiving federal financial assistance.

Requirements

Any programs or activities that receive federal transit funding must comply with Title VI. Any agency receiving federal dollars either directly from FTA (Federal Transit Administration), indirectly through WisDOT or both, must:

- Promote full and fair participation in transportation decision-making without regard to race, color or national origin
- Ensure meaningful access to transit-related programs and activities by persons with limited English proficiency
- Ensure the level and quality of transportation service is provided in a nondiscriminatory manner
- Prepare and submit a Title VI Plan.
