

If your \Box Certificate of Vehicle Registration or license plate sticker needs to be replaced because it has been lost, stolen, destroyed, or damaged, you can obtain a duplicate:

Online

Orders that include license plate sticker will be mailed to the address you request. Orders for Certificate of Vehicle Registration only (no sticker) will be produced as a PDF for you to print. The PDF also will be emailed to you.

To use the application, you need:

- To be the registered owner, lessee or driver of the vehicle (must be an individual, not a business)
- A valid email address
- Your Wisconsin driver license or identification card number
- The last four digits of your Social Security Number
- Your date of birth
- The □ vehicle identification number (VIN) for the vehicle needing the duplicate Certificate of Registration or sticker

If you are ordering a Certificate of Vehicle Registration with replacement sticker or a Certification of Vehicle Registration only, you also need:

- A valid credit or debit card (Visa, MasterCard, Discover or American Express) or ACH (Automated Clearing House) payment through your checking/savings account (eCheck automatic withdrawal from your bank account)
 - For ACH payments, your account will be charged a \$2 application fee
 - For credit or debit card payments, your account will be charged a \$2 application fee and a convenience fee

If you are ordering a Certificate of Vehicle Registration only (no sticker), you also need:

- A printer with standard white 8 1/2 x 11 inch paper
- Adobe Acrobat Reader The Certificate of Registration is produced as a PDF for you to print. It will not be mailed

Once the online transaction is completed, you cannot cancel it or receive a refund. Verify that you have entered the information correctly before completing payment information. If your registration is expired, or is due for renewal and you want to renew the registration now, use the \Box online license plate renewal application.

This service may not be available on Sundays from 6 a.m.–9 a.m. due to regular system maintenance.
