Auto plates, most specialty plates, and light truck plates expire in every month.

- Vehicle type eligible for quarterly registration if registered gross weight is greater than 8,000 pounds
- * Two year registration period. Registration period expires on the last day of April, even years.
- » Registration period expires June 30, 2023 for School bus; all others expire December 31, 2019. Five-year registration period.
- † Optional 6 year registration for fleets of 100 or more vehicles
