

The Federal Driver's Privacy Protection Act passed by Congress in 1994 and ruled constitutional by the U.S. Supreme Court in January of 2000 restricts access to Division of Motor Vehicle (DMV) records. The act is intended to protect the privacy of personal information relating to driver licenses and instruction permits, vehicle titles and registrations and identification cards issued by motor vehicle departments.

A Vehicle/Driver Record Information Request form Information about a Wisconsin vehicle/driver record can be obtained. WisDOT will not provide most DMV records unless the records are obtained for one of the specific reasons listed on the Vehicle/Drivers Record Information Request Form.

It is the responsibility of the requester, not the Division of Motor Vehicles, to determine eligibility. If

the form is completed fraudulently, the requester may be assessed fines under the federal act.
