Veterans Professional/Occupational Licensure Fee Waiver Program (2011 Wisconsin Act 209)

What is the Veterans Professional/Occupational Licensure Fee Waiver Program?

Wisconsin Act 209 (effective July 1, 2012) requires that the Wisconsin Department of Veterans Affairs (WDVA) establish and maintain a program under which 13 state licensing agencies (including the Wisconsin Department of Transportation - WisDOT) grant fee waivers to qualified veterans when issuing initial licenses. WisDOT licenses eligible for the fee waiver program are listed below.

Under this program:

- Only one initial license fee waiver will be allowed per qualified applicant.
- The fee waiver applies only to licenses that are issued to individuals, and not to licenses issued to businesses or other entities.
- Waivers are not permitted for license renewals; they are for one initial license only.

How to apply for a waiver

The WDVA determines eligibility for this program. To be qualified for a fee waiver, a veteran must

be a Wisconsin resident and must have been honorably discharged from the U.S. armed forces.

The WDVA will issue a voucher to applicants who are deemed eligible for a fee waiver. To apply for a voucher, please visit the WDVA's Eligibility webpage.

Redeem your voucher

You may redeem your voucher for one of the license categories below when you apply for your **initial** license.

Each licensing program has guidelines and procedures in place regarding licenses they issue. For details on these procedures, click on the relevant license category.

WisDOT licenses eligible for the Veterans Fee Waiver Program:

- Driving instructor license
- Representative license
- Salesperson license
- Salvage buyer identification (BID) card

Related information

For the license types listed above, Wisconsin Act 120 (effective July 1, 2012) enables veterans to request consideration that their military training/education/experience be used to satisfy licensure requirements, if an applicant can demonstrate equivalency to the requirements for license issuance.
