

Buyers license - A tool for motor vehicle auctions

The "Buyers License Report" list: It shows all currently licensed Wisconsin motor vehicle buyers authorized to bid and buy at vehicle auctions. The list includes license holder's name, Wisconsin Department of Transportation dealer number, employing dealer name, city and state the dealer is located in, and date the buyers license expires.

The

"Dealership Owners – Individuals Report" list: It shows the names of all licensed Wisconsin

motor vehicle dealer owners. The list includes the dealer name and owner name only. Non-individual owners are not listed on this report.

Salvage Buyer Identification (BID) card license

The "BID Card License Report" list is a tool for motor vehicle salvage auctions. It shows all currently licensed Wisconsin motor vehicle salvage buyers authorized to bid and buy at salvage vehicle auctions. The list includes license holder's name, Wisconsin Department of Transportation (WisDOT) dealer number, employing dealer name, city and state, and the date the bid card license expires.

Salvage dealers

The "Salvage Dealers" list is a tool for consumers, municipalities, and law enforcement. It shows all currently licensed Wisconsin motor vehicle salvage dealers. The list includes the business name and address, including city, state, zip code and county; the Wisconsin Department of Transportation (WisDOT) dealer plate number, and date the salvage license expires.

Motor vehicle dealers

The "Motor Vehicle Dealers" list is a tool for consumers, municipalities, law enforcement, and other dealers. It shows all currently licensed Wisconsin retail motor vehicle dealers. The list includes the dealer plate number, name and address of the dealership, and the expiration date of the dealer license.

Motorcycle dealers

The "Motorcycle Dealers" list is a tool for consumers, municipalities, law enforcement, and other dealers. It shows all currently licensed Wisconsin motorcycle dealers. The list includes the dealer plate number, name and address of the dealership, and the expiration date of the dealer license.

Auction dealers

The "Auction Dealers" list is a tool for other dealers; it shows the name and address of auction dealers, including their dealer license number and the date their license expires.

Wholesale dealers

The "Wholesale Dealers" list is a tool for other dealers, consumers, municipalities and law enforcement. It shows all currently licensed Wisconsin wholesale dealers. The list includes the dealer plate number, name and address of the dealership, and the expiration date of the dealer license.
