Eligibility

Collector special license plates are available to any Wisconsin motorist who has one or more vehicles registered with [Collector plates](#). They may be issued to a vehicle of any age used for

general transportation. The applicant for Collector special plates must be an owner or lessee of the vehicle.

Vehicles that qualify:

- automobiles
- motor homes (annual registration only)
- trucks
 - 4,500, 6,000 or 8,000 pounds gross weight including dual purpose farm and dual purpose motor home
 - 12,000 pounds gross weight farm truck

Things you should know:

- A \$15 issuance fee is required.
- The regular annual registration fee for the vehicle type is collected.
- Collector Special plates feature the same design as standard plates except they display the words "Vehicle Collector" at the bottom.
- Your first Collector Special plate will have the same number as your collector number.
- Subsequent vehicles registered with Collector Special plates will have your collector number plus a letter suffix.
- Collector special plates cannot be personalized, other than the Collector number and suffix.

How to apply:

Collector Special license plates are not available at local [DMV customer service centers](#). To apply, send the following items:

1. If the vehicle you want to register with Collector special plates is already titled/registered in your name, send:
 - A written request for Collector Special plates and a copy of your Certificate of Registration, **or** submit form [MV1 Wisconsin Title & License Plates Application](#)
 - \$15 issuance fee
 - The annual registration fee if current plates expire within the next three months or you have no plates
2. If the vehicle is **not** titled/registered in your name, send:
 - A completed Wisconsin Title & License Plates Application [MV1](#), or MV11 for dealer sales, including all other fees due
 - A written request for Collector Special plates, including your regular Collector license plate number, or submit form MV1
 - The Certificate of Title assigned to you by the seller
 - \$15 issuance fee
 - The annual registration fee if you do not have plates or your current plates expire within the next three months
3. Make the check or money order made payable to **Registration Fee Trust**.
